POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 27 MAY 2019

Reference is made to the circular dated 17 April 2019 (the “**Circular**”) issued by Kingboard Laminates Holdings Limited (the “**Company**”). Unless the context otherwise requires, capitalised terms used in this announcement have the same meaning as those defined in the Circular.

At the AGM held at 23/F, Delta House, 3 On Yiu Street, Shek Mun, Shatin, New Territories, Hong Kong on 27 May 2019, all the ordinary resolutions proposed were duly passed by way of poll.

As at the date of the AGM, a total of 3,081,000,000 ordinary shares of the Company were in issue and entitled the holders of which to attend and vote at the AGM.

The respective Directors who is also a shareholder of the Company and subject to re-election at the AGM abstained from voting on the respective resolution concerning his own re-election. Save as disclosed above, there were no restrictions on any shareholders to cast votes on any of the proposed resolutions at the AGM. No Shareholder was required to attend and vote only against the proposed resolutions at the AGM.
