



Hexavalent Chromium (Cr(VI)) Testing Flow Chart















Persistent, Bioaccumulative, and Toxic (PBT) Chemicals Testing Flow Chart









#### Halogen Testing Flow Chart









Red phosphorus Testing Flow Chart






