



Hexavalent Chromium (Cr(VI)) Testing Flow Chart





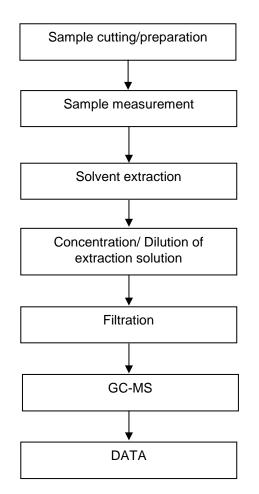

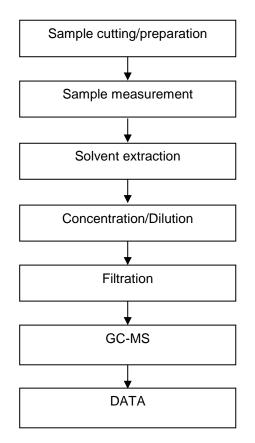





Chlorinated Paraffin Testing Flow Chart







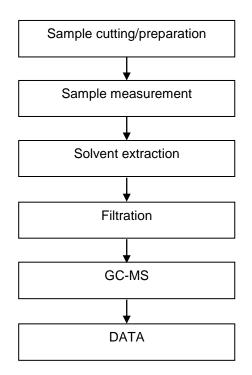

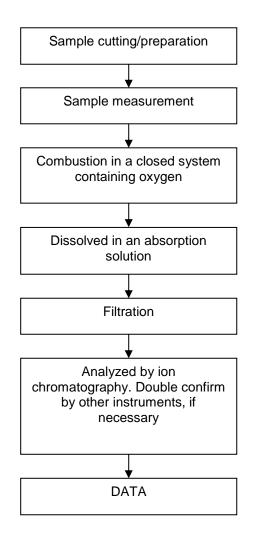

Halogen Testing Flow Chart





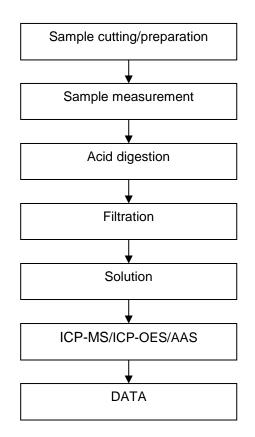





DMF (Dimethyl fumarate) Testing Flow Chart










