



### Hexavalent Chromium (Cr(VI)) Testing Flow Chart







### **PBB/PBDE Testing Flow Chart**



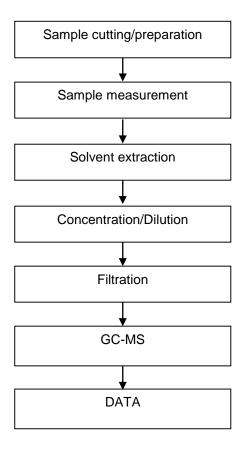
