



### Hexavalent Chromium (Cr(VI)) Testing Flow Chart







### **PBB/PBDE Testing Flow Chart**





### **Phthalates Testing Flow Chart**







## Persistent, Bioaccumulative, and Toxic (PBT) Chemicals Testing Flow Chart





### **Halogen Testing Flow Chart**










