





#### PBB/PBDE/Phthalates Testing Flow Chart





### **PAHs Testing Flow Chart**







### **Chlorinated Paraffin Testing Flow Chart**







### **Bisphenols Testing Flow Chart**







### **DMF (Dimethyl fumarate) Testing Flow Chart**





#### **HBCDD Testing Flow Chart**







#### **Phthalates Testing Flow Chart**






