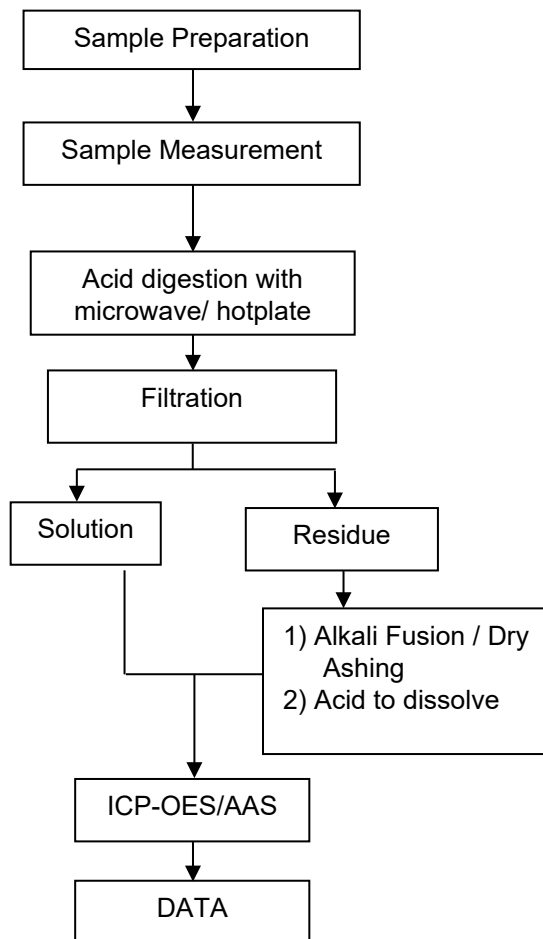

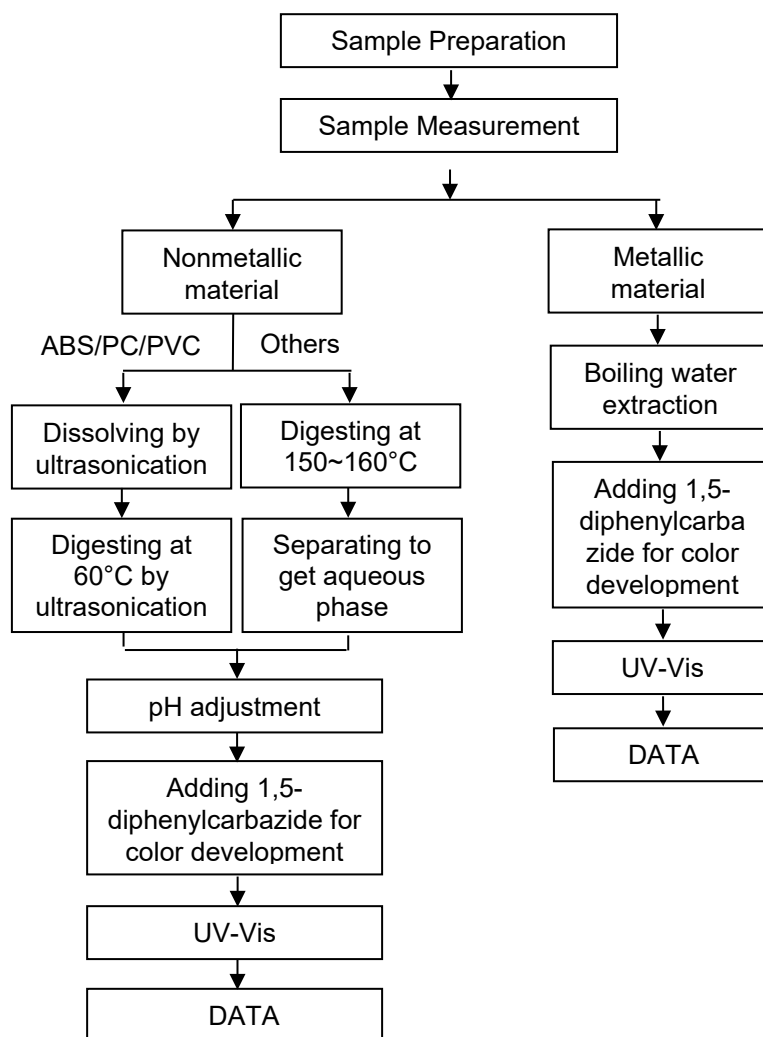

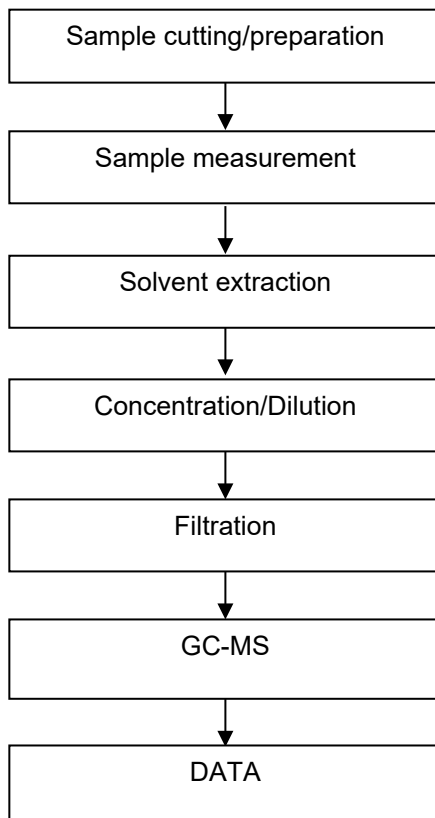

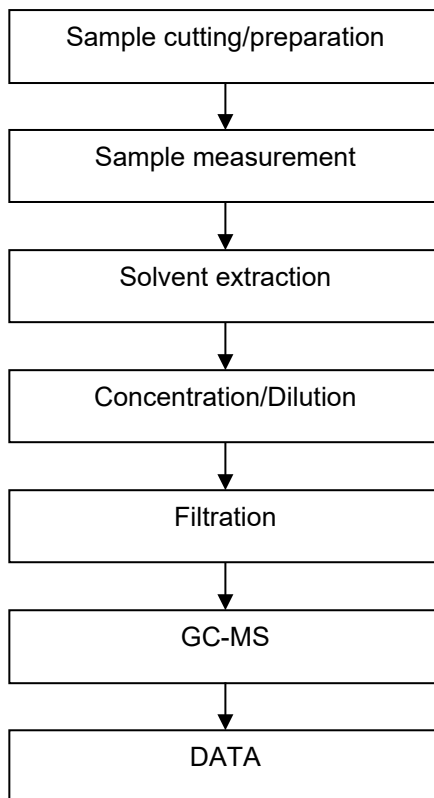

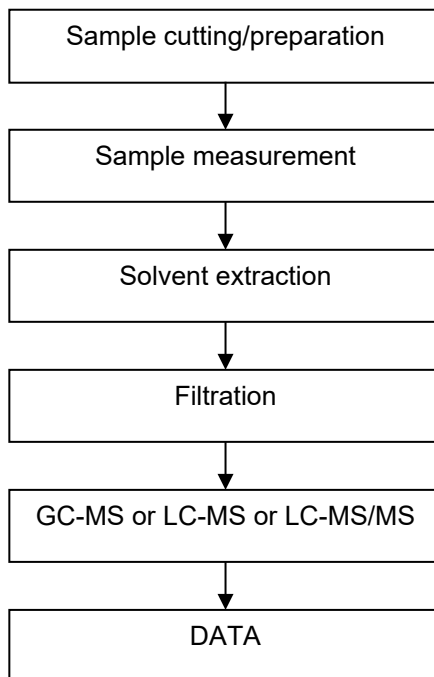

TBBP-A Testing Flow Chart



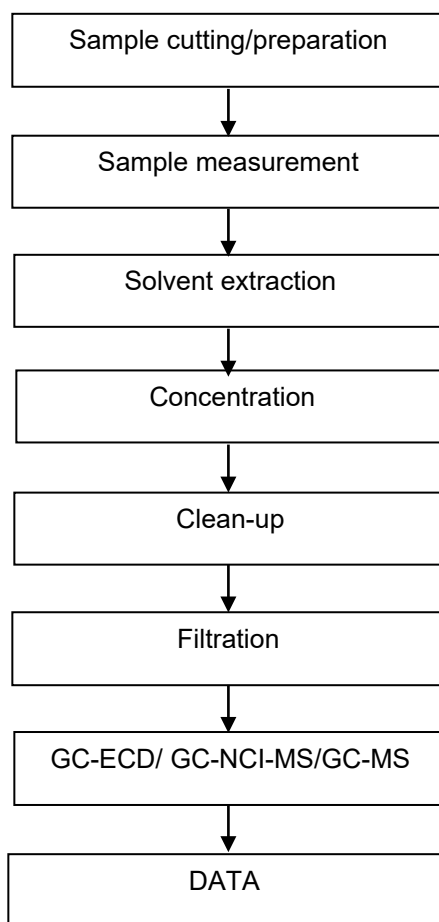

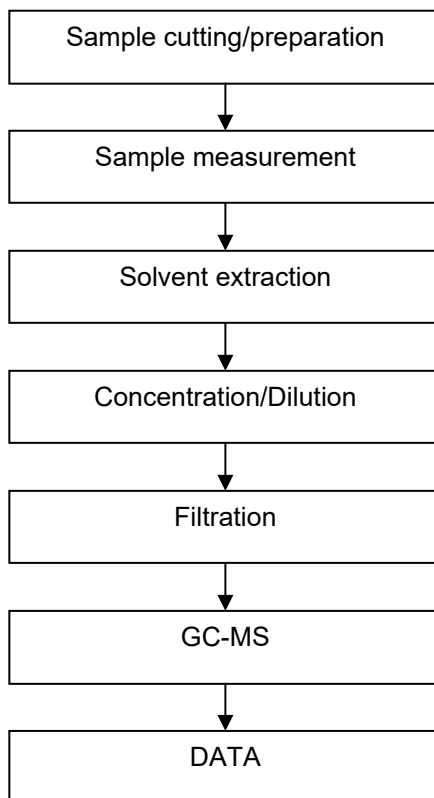

HBCDD Testing Flow Chart



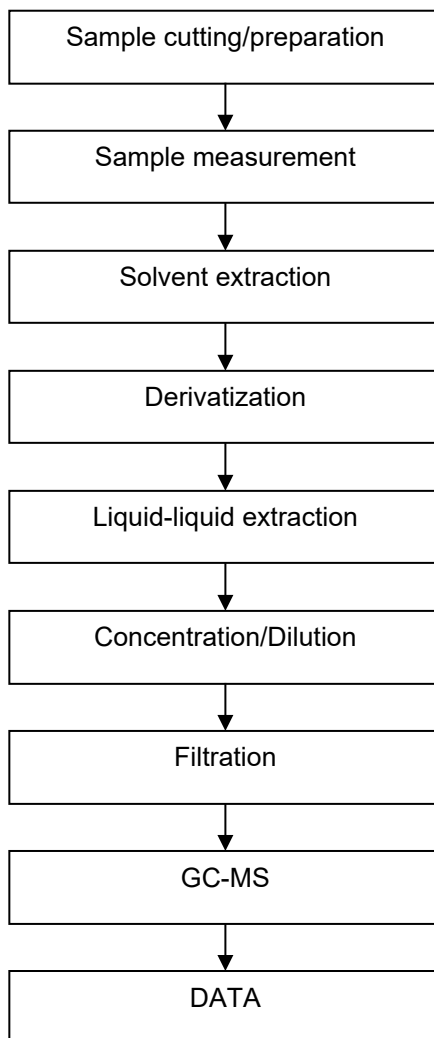

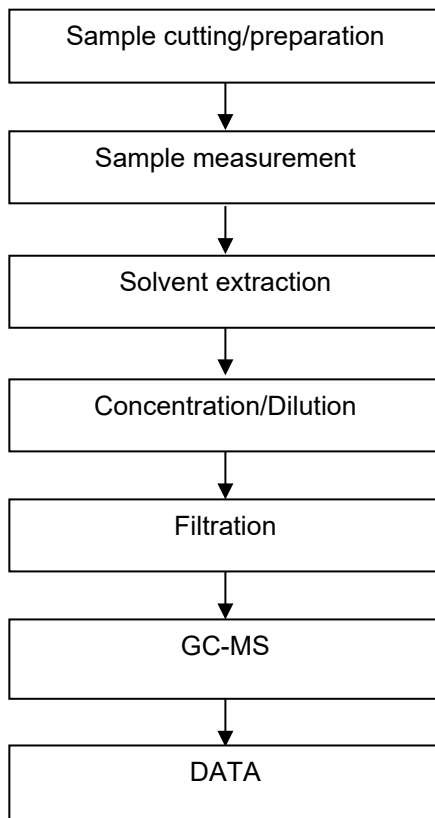

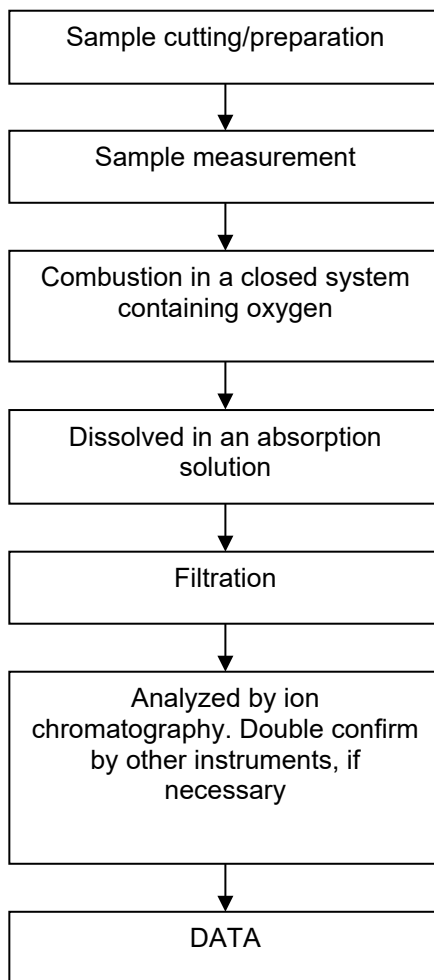

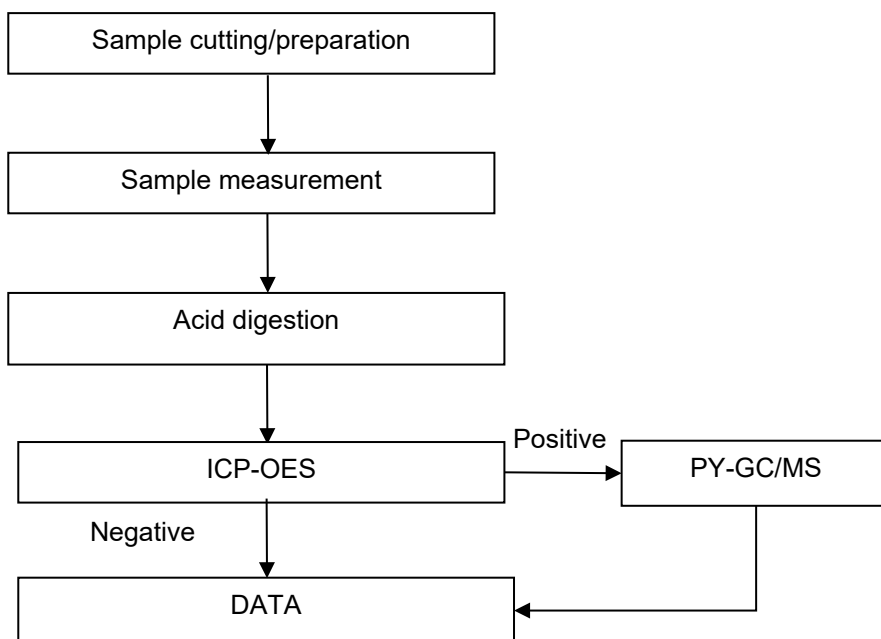

Red phosphorus Testing Flow Chart



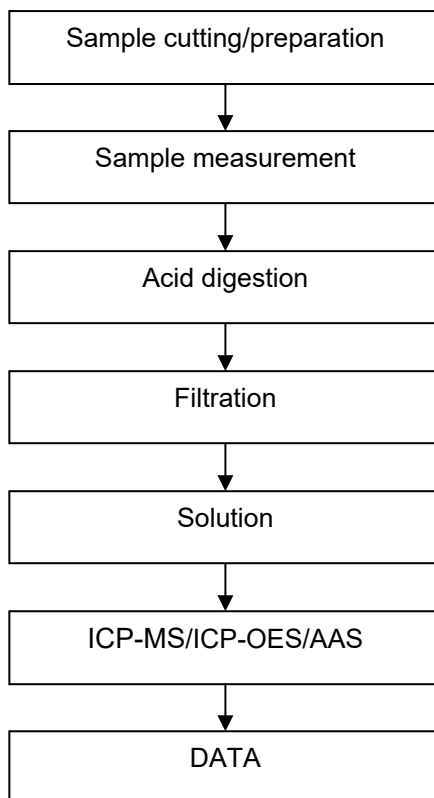
