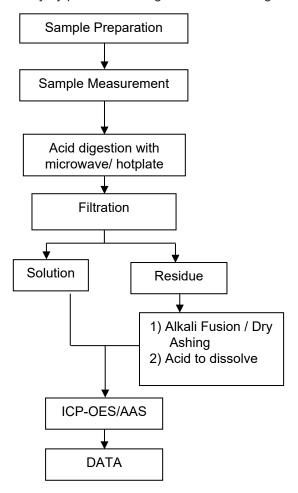

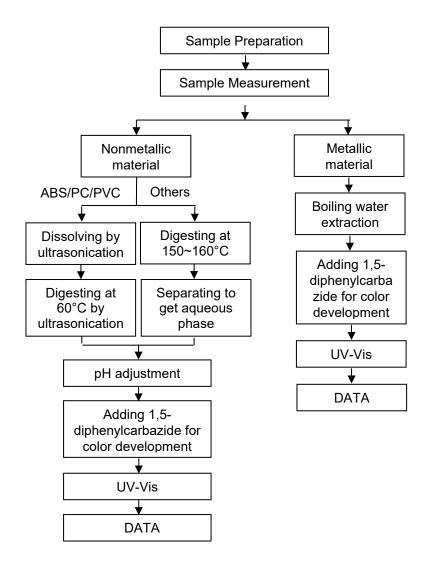

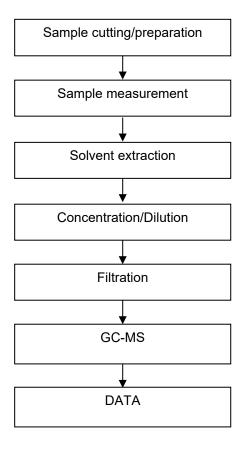

PBB(s)/PBDE(s)/Phthalates Testing Flow Chart





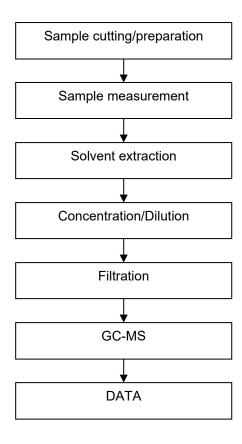

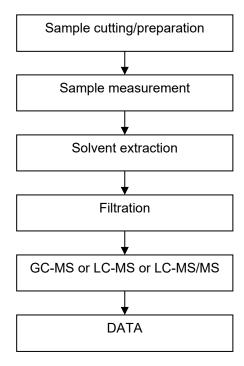

TBBP-A Testing Flow Chart





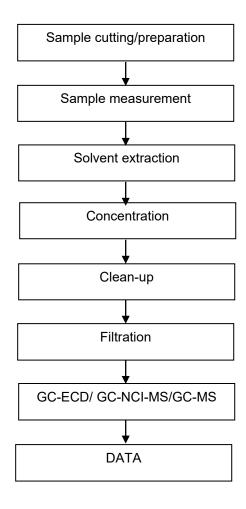

Chlorinated Paraffin Testing Flow Chart





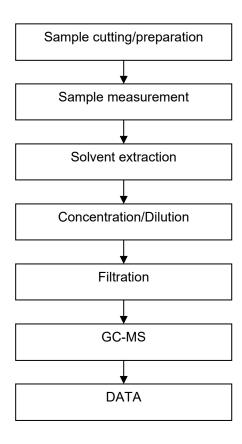

HBCDD Testing Flow Chart





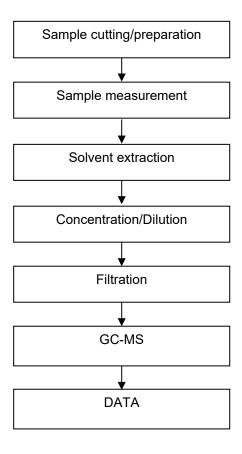

Phthalates Testing Flow Chart





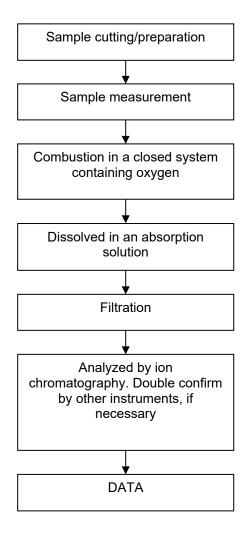

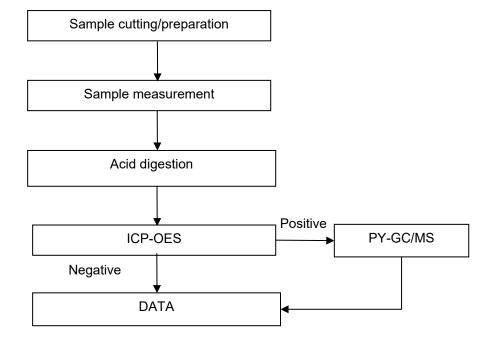

Red phosphorus Testing Flow Chart





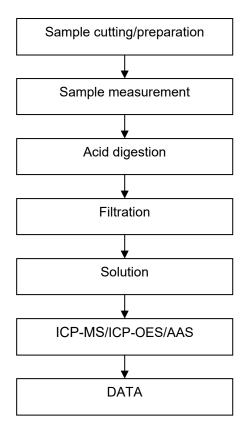

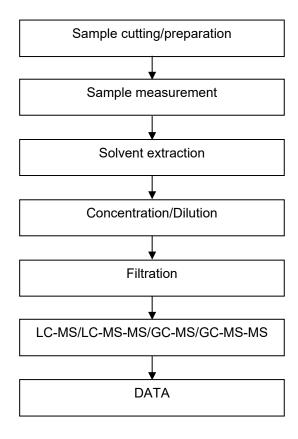
