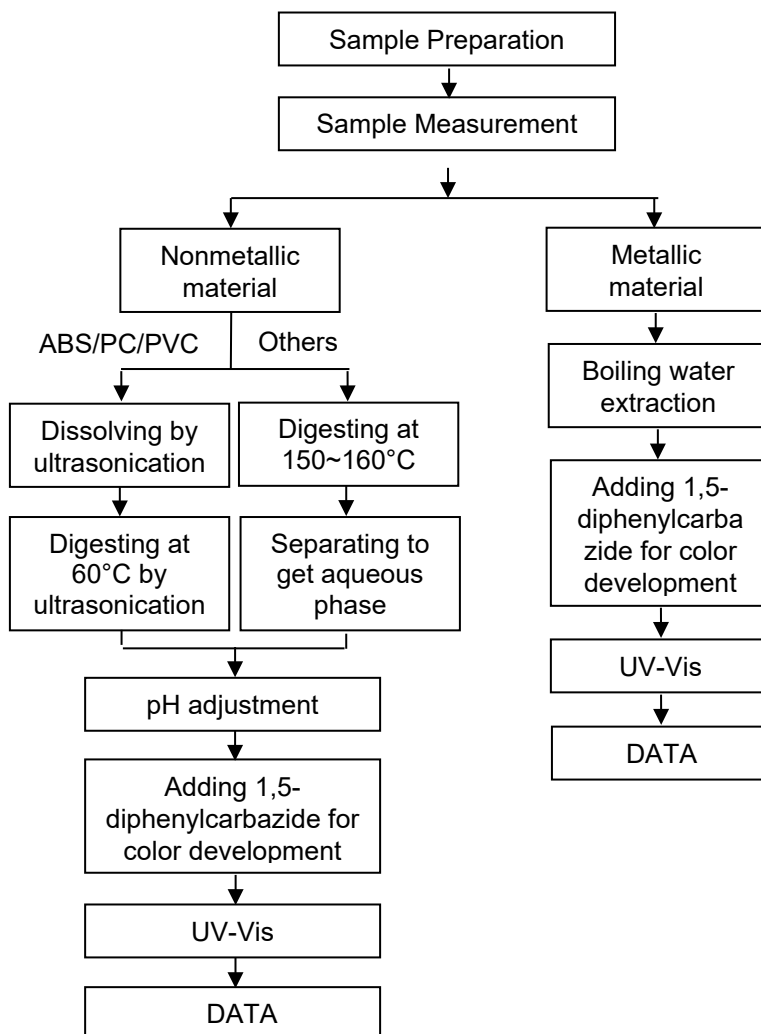

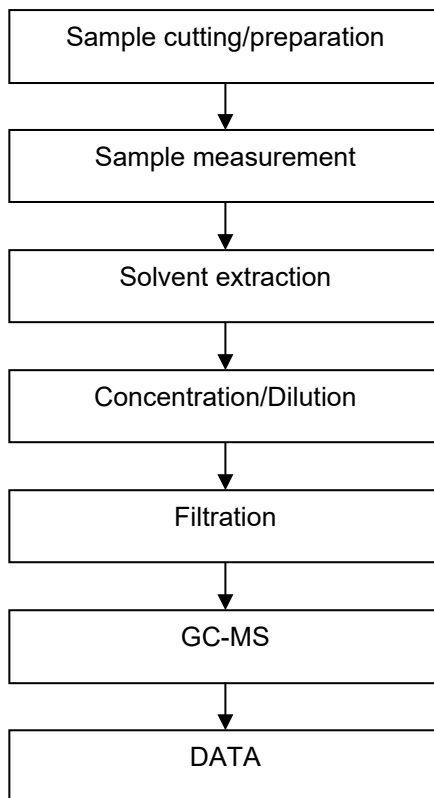

PAHs Testing Flow Chart



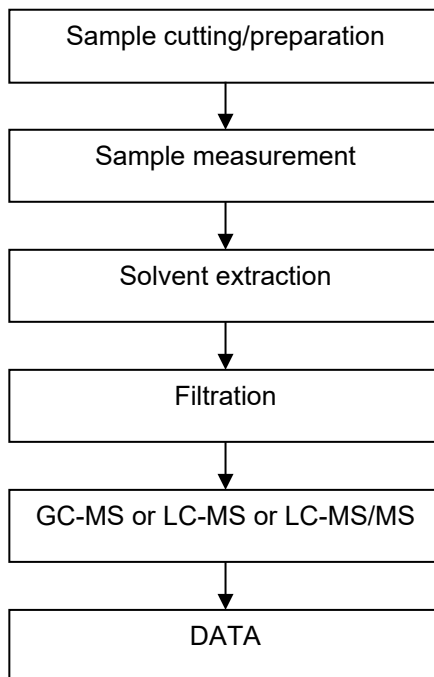

Phthalates Testing Flow Chart

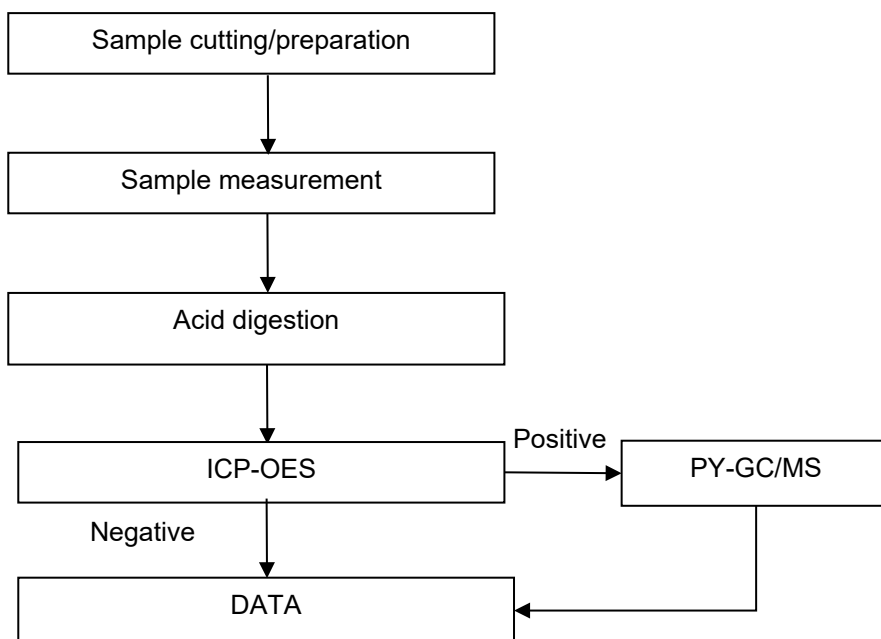


Halogen Testing Flow Chart

Red phosphorus Testing Flow Chart



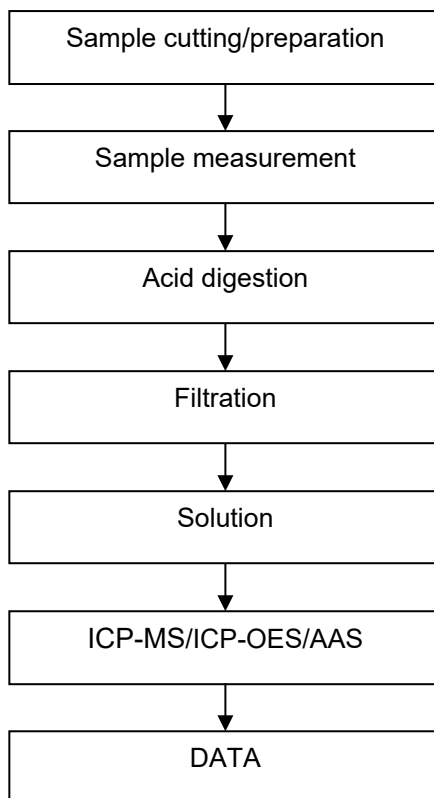

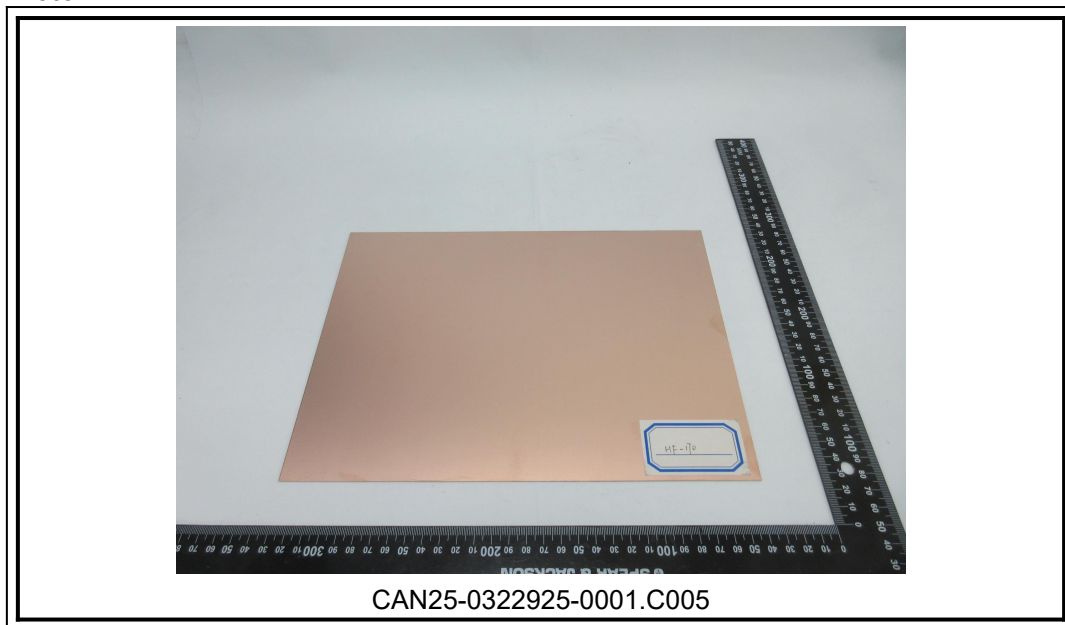
