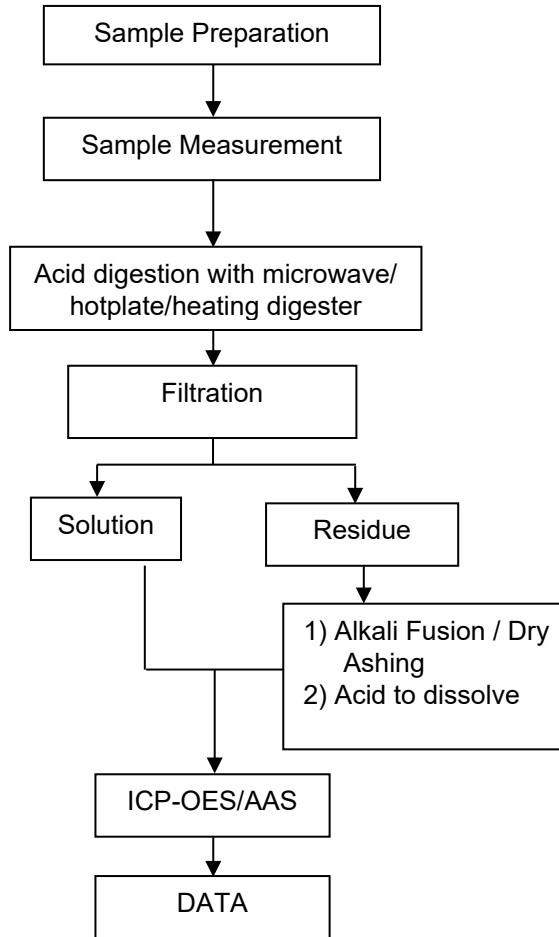

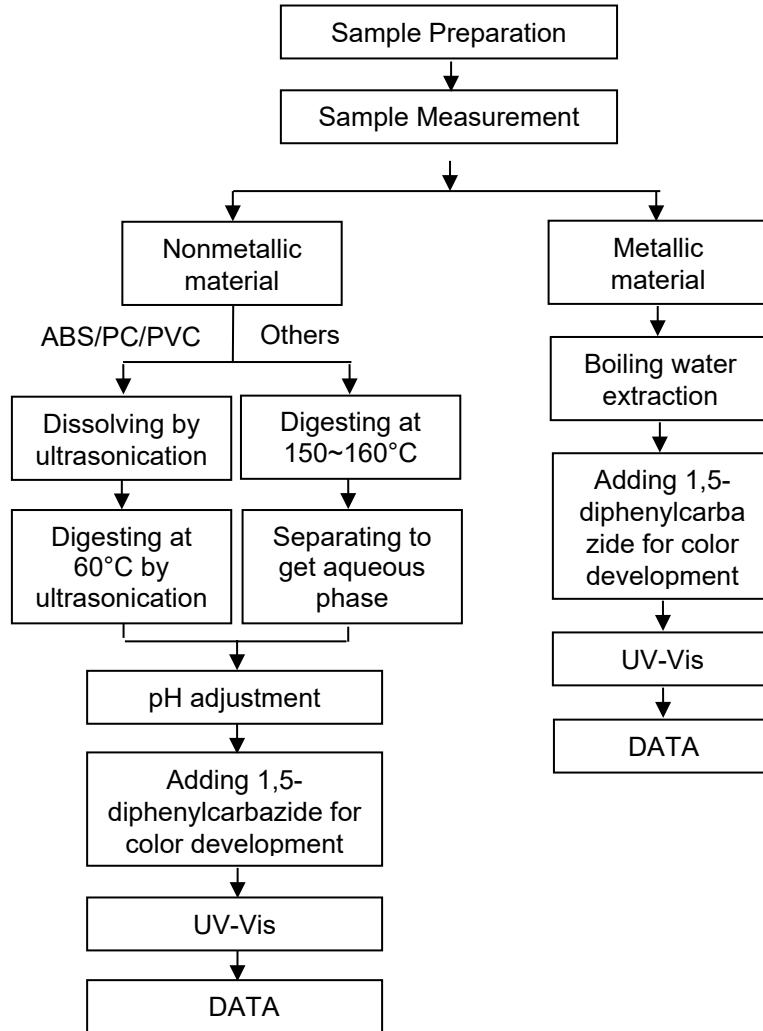

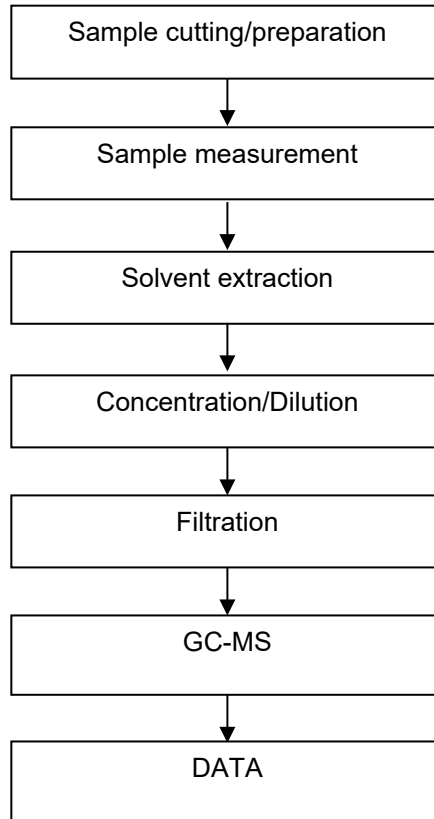

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**



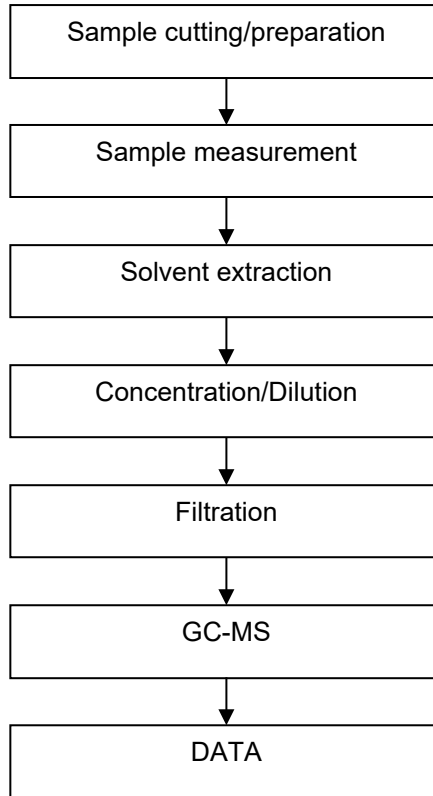

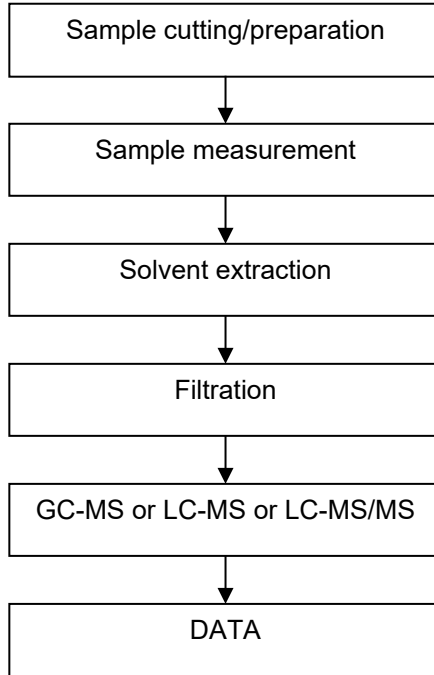

### PAHs Testing Flow Chart

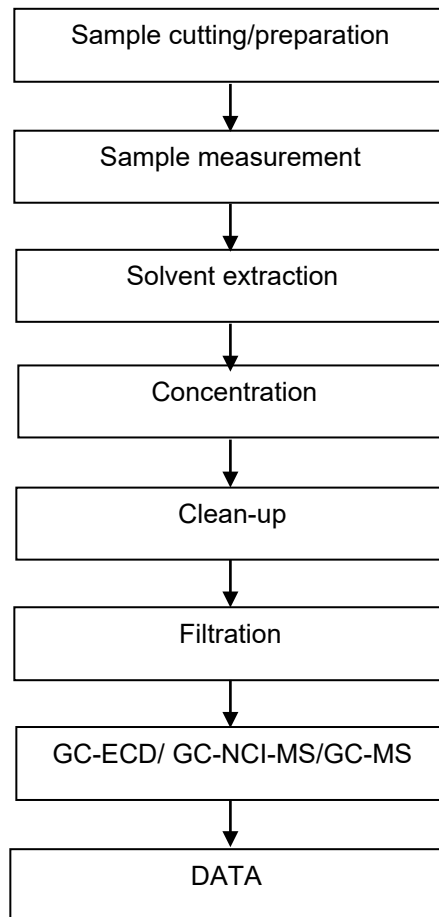

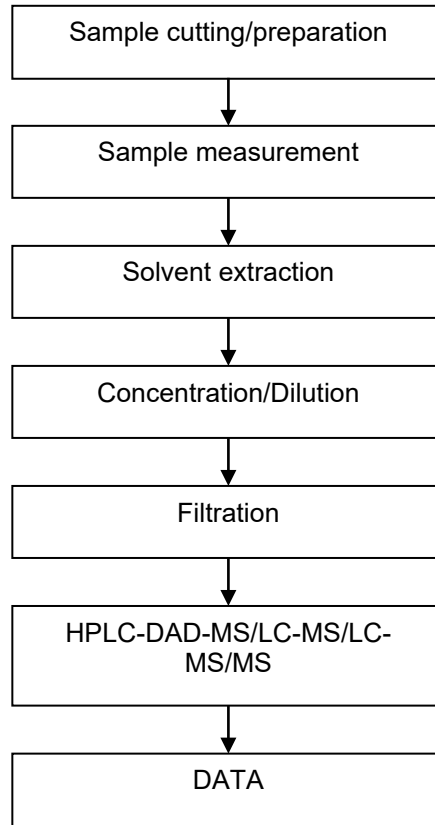

## Chlorinated Paraffin Testing Flow Chart

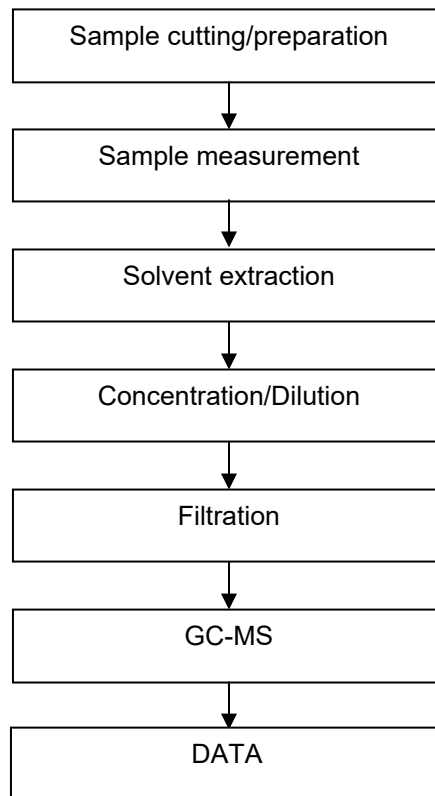


### Bisphenols Testing Flow Chart

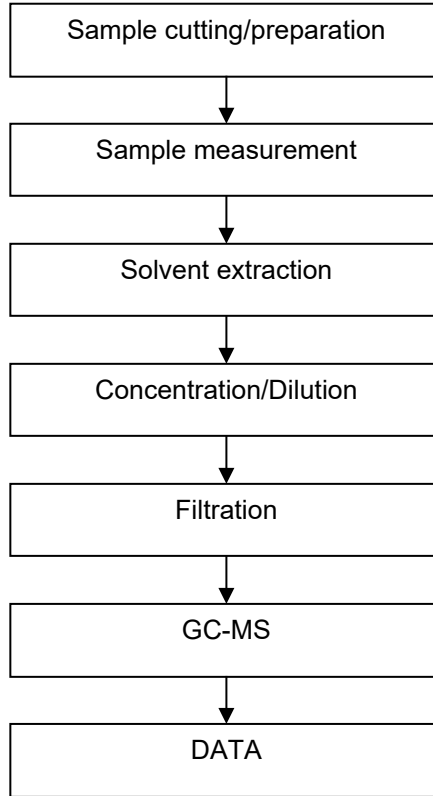

### DMF (Dimethyl fumarate) Testing Flow Chart

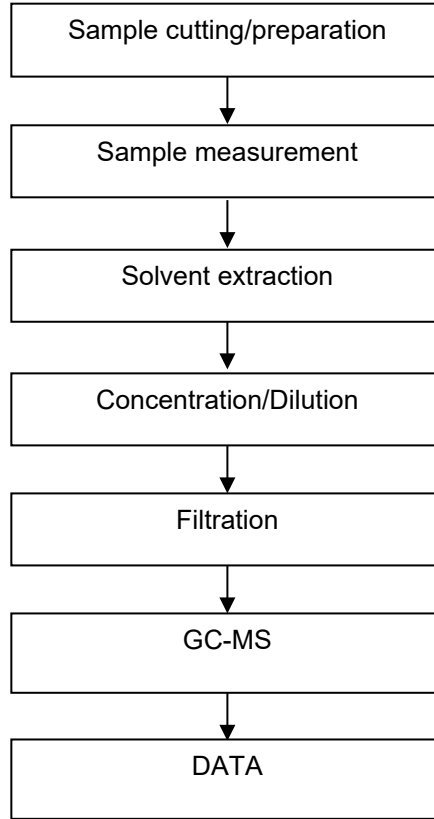


### HBCDD Testing Flow Chart

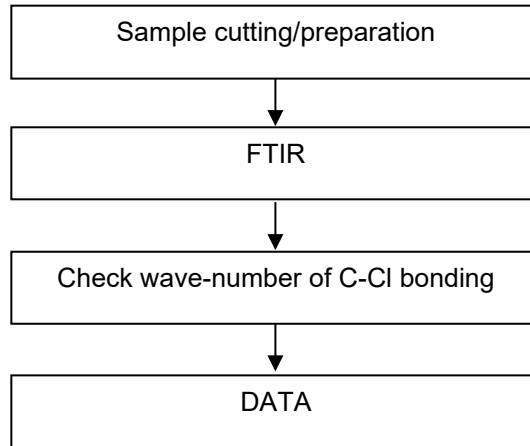

### Phthalates Testing Flow Chart

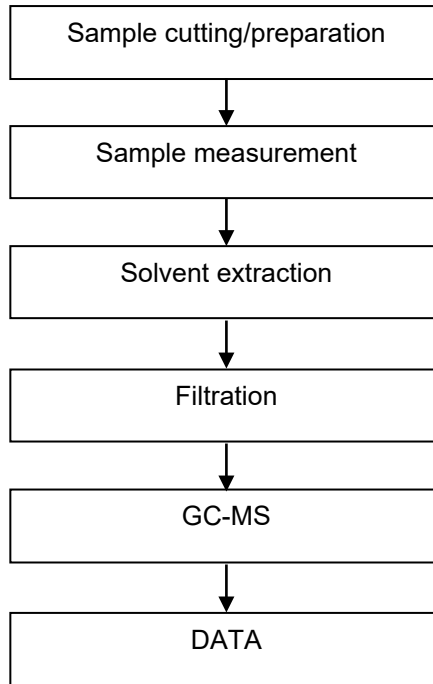


### PVC Testing Flow Chart

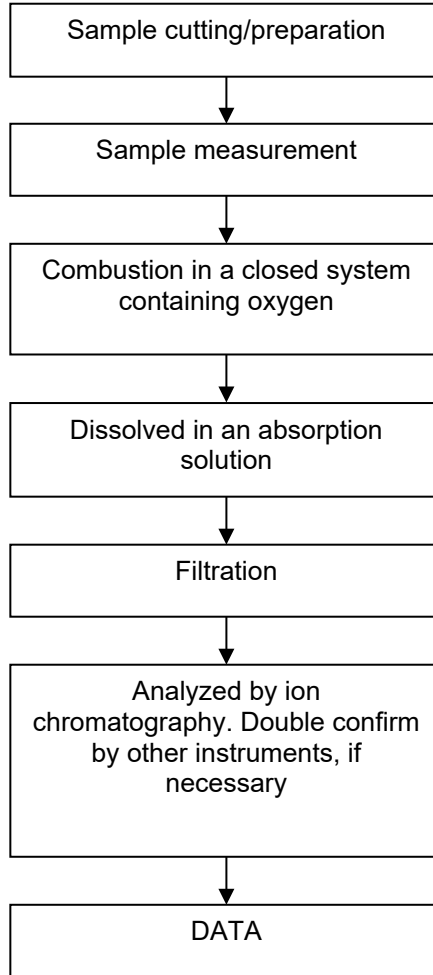

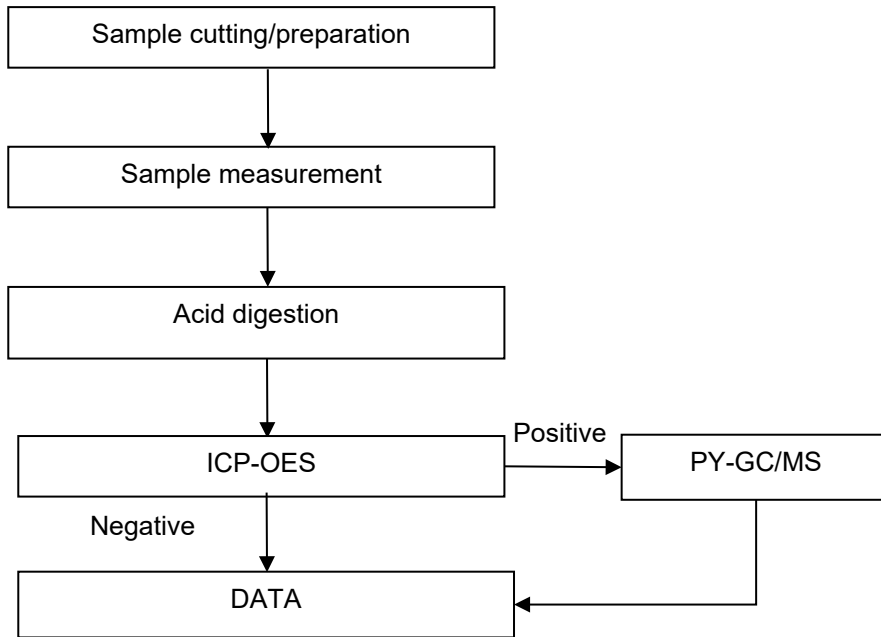

**Halogen Testing Flow Chart**



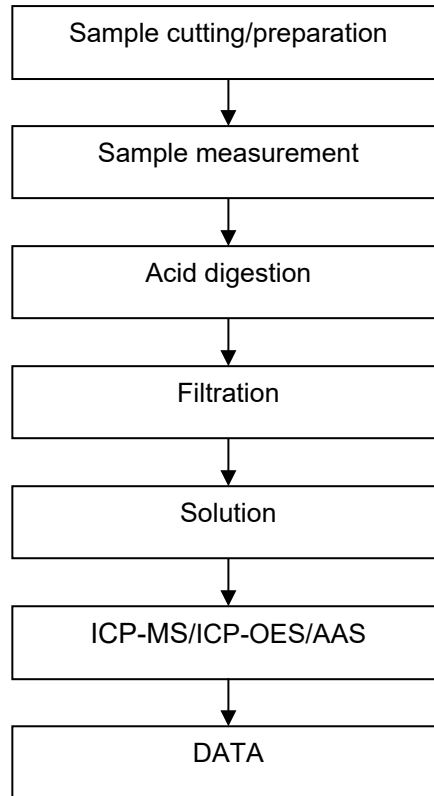

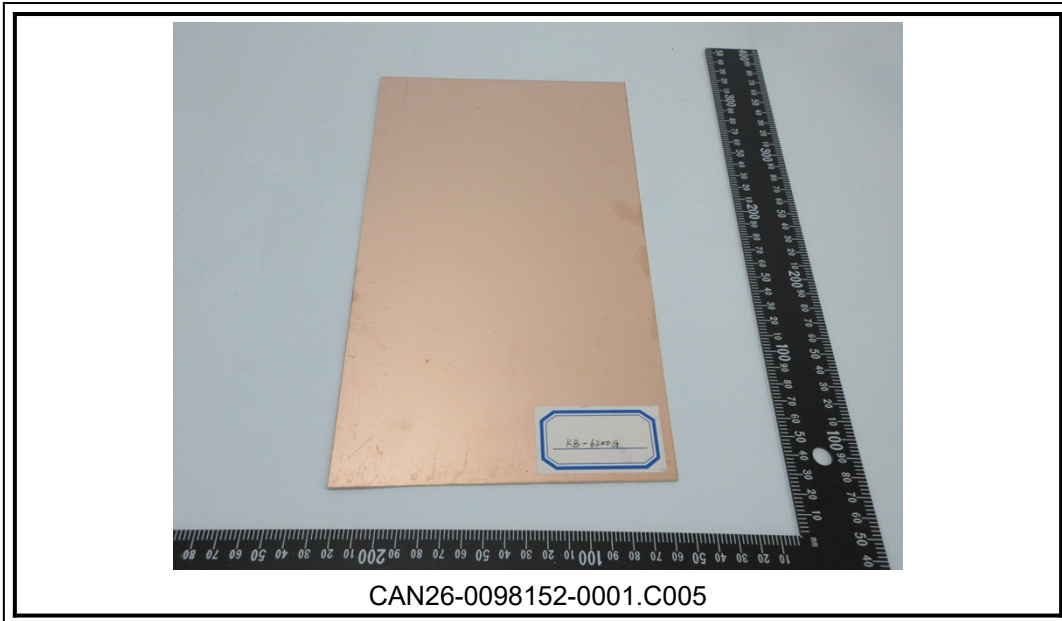
