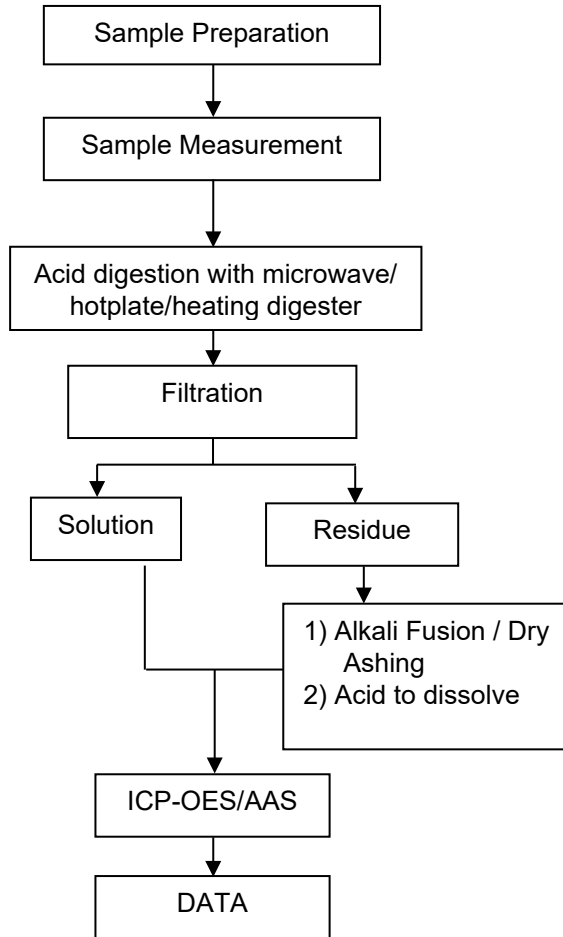

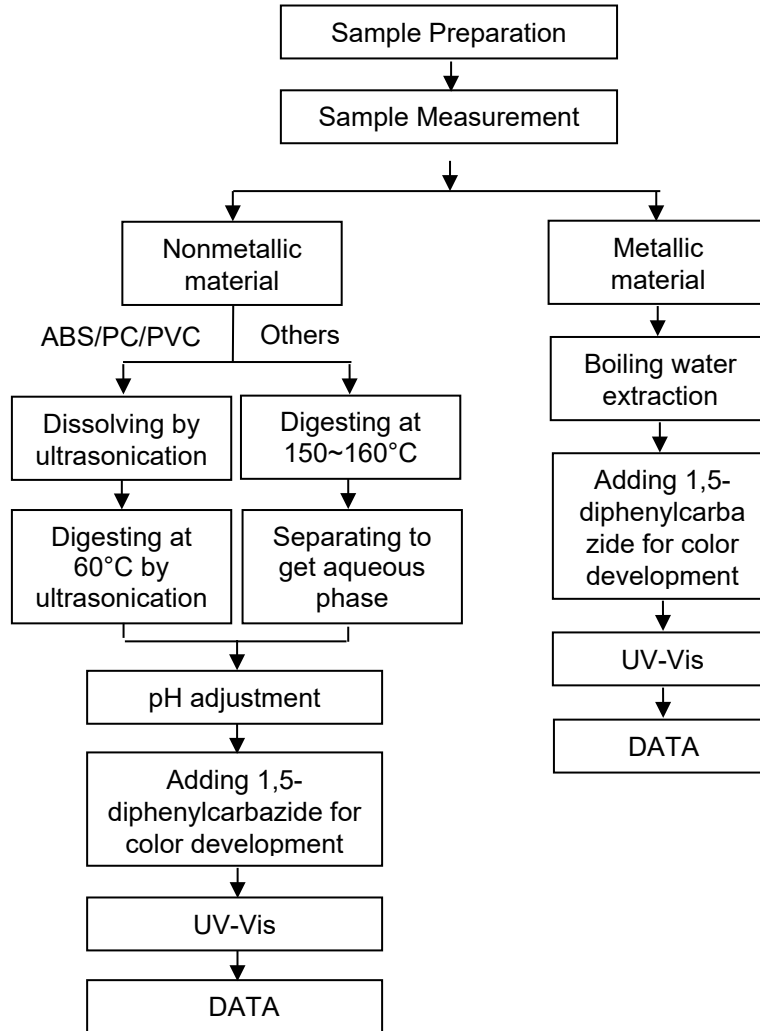

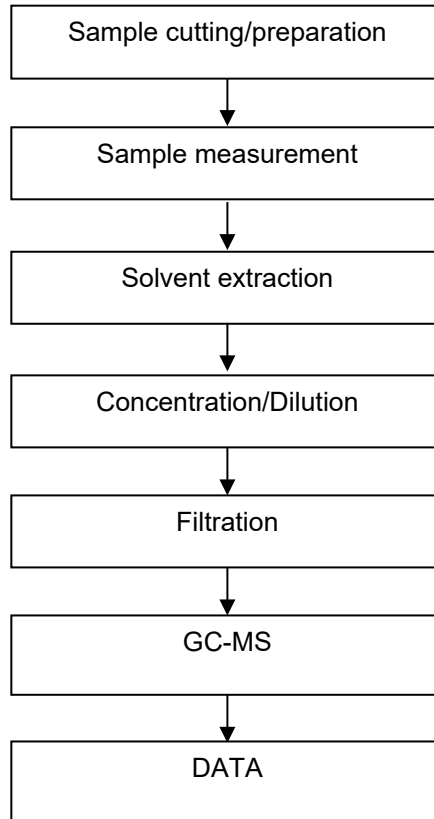

**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**



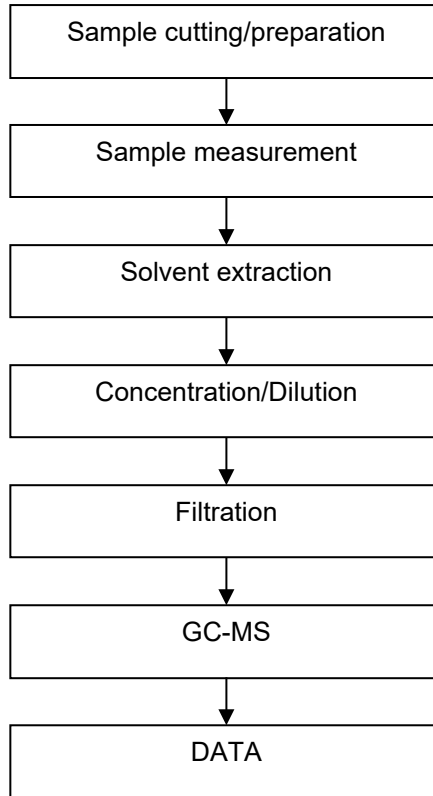

**PBB(s)/PBDE(s)/Phthalates Testing Flow Chart**



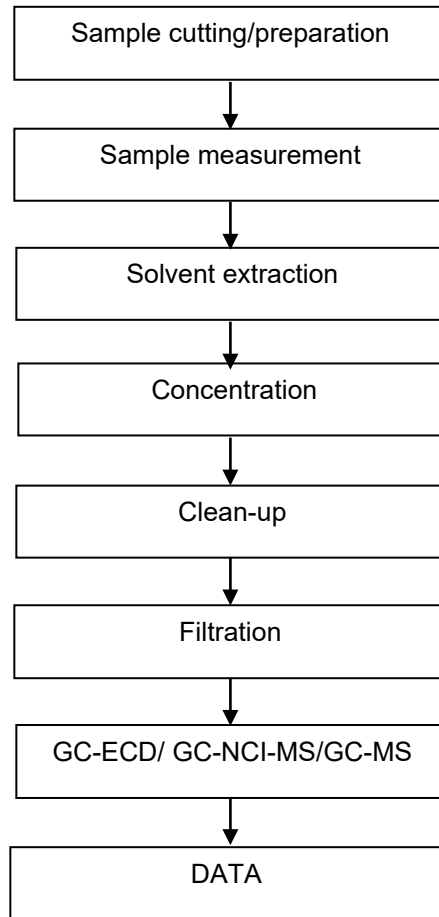

### PAHs Testing Flow Chart



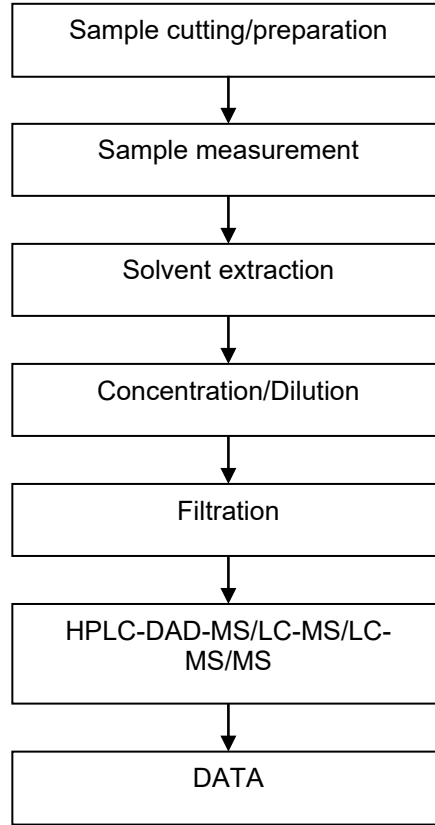

## Chlorinated Paraffin Testing Flow Chart



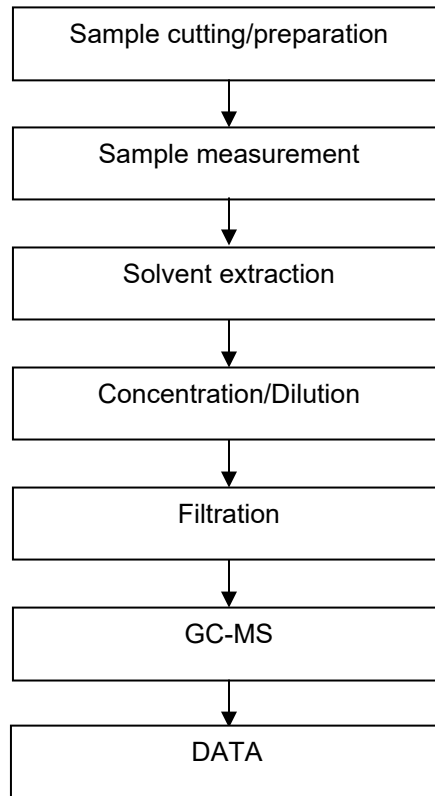

## Bisphenols Testing Flow Chart

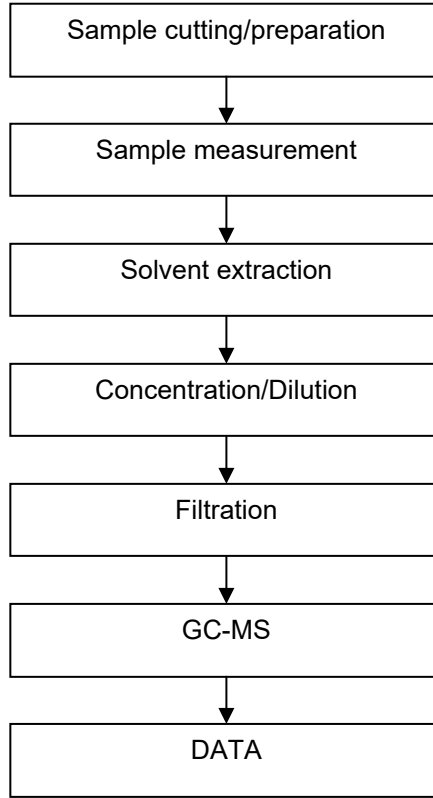

## DMF (Dimethyl fumarate) Testing Flow Chart

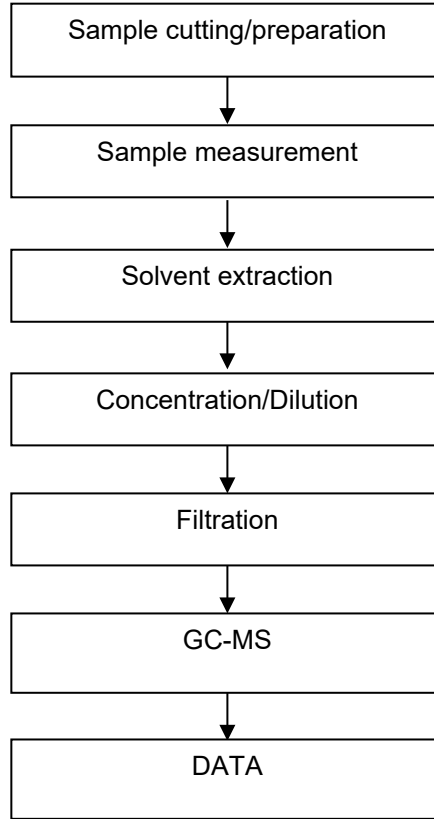

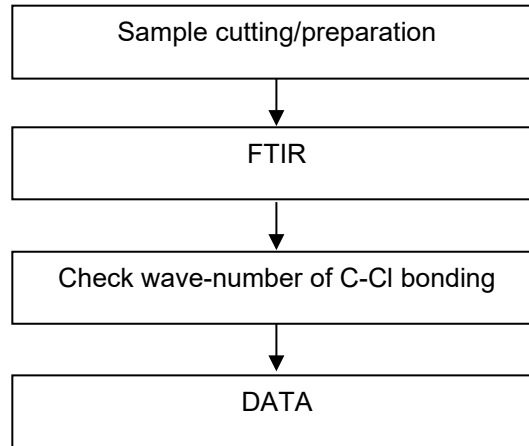

### PVC Testing Flow Chart

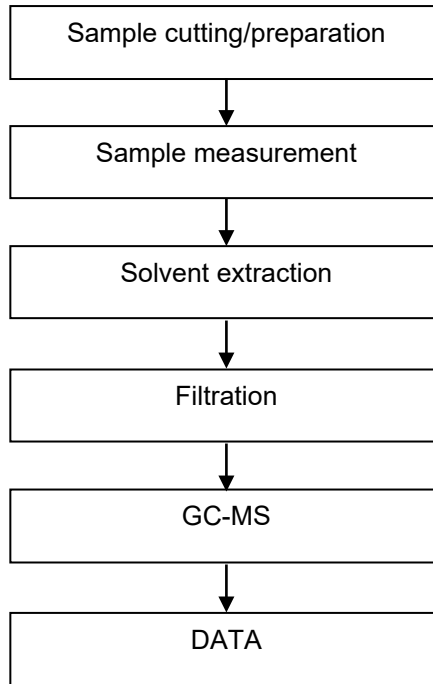

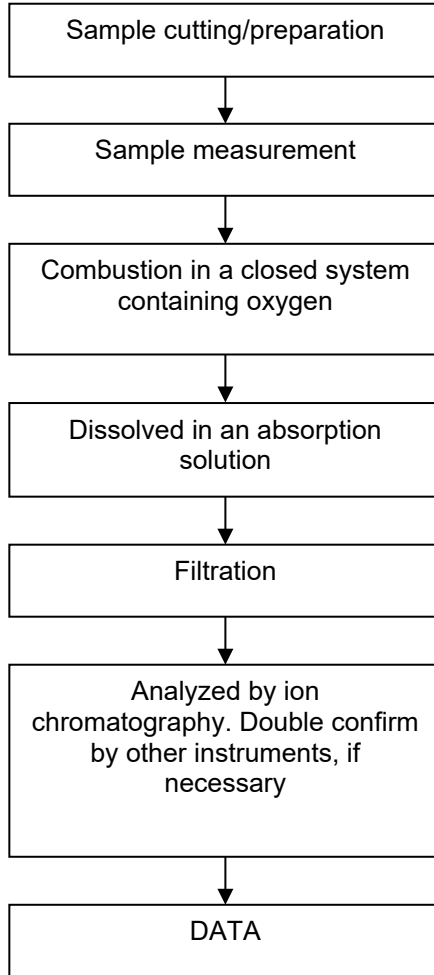

### Persistent, Bioaccumulative, and Toxic (PBT) Chemicals Testing Flow Chart



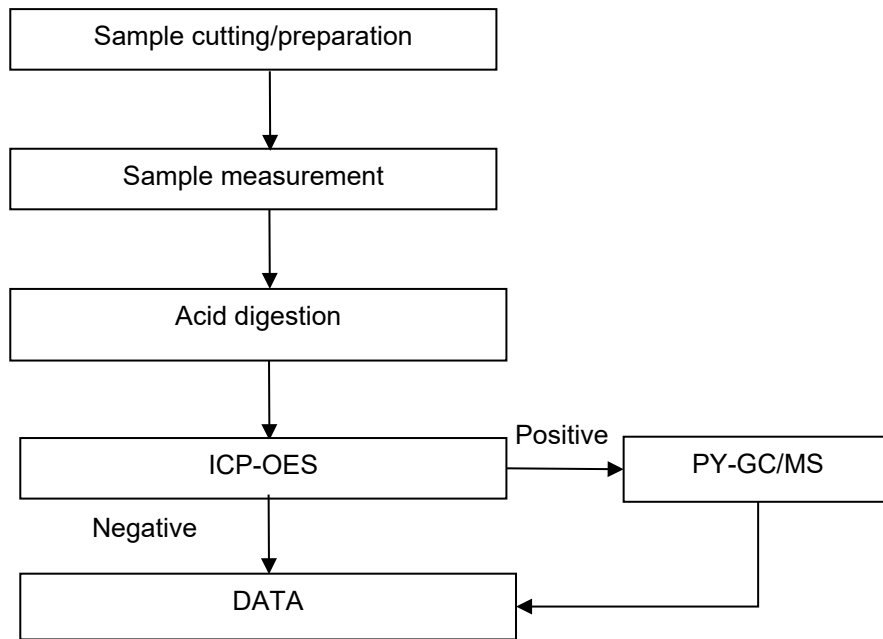

### Halogen Testing Flow Chart



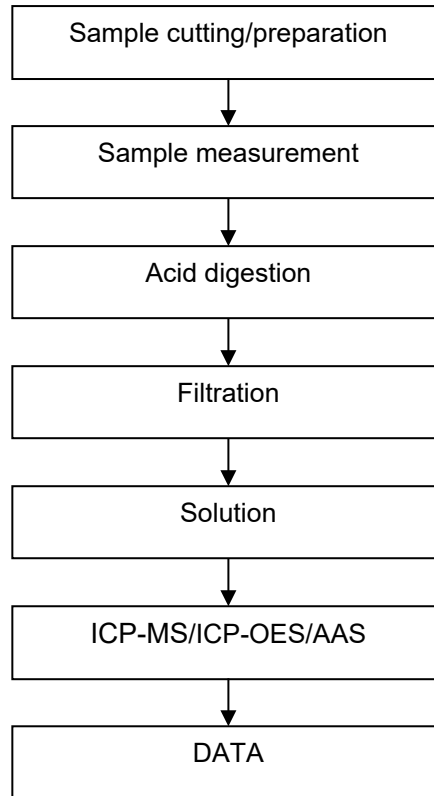

Red phosphorus Testing Flow Chart



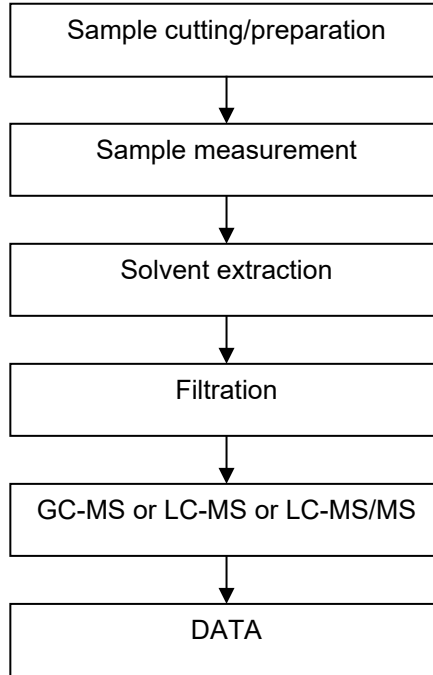

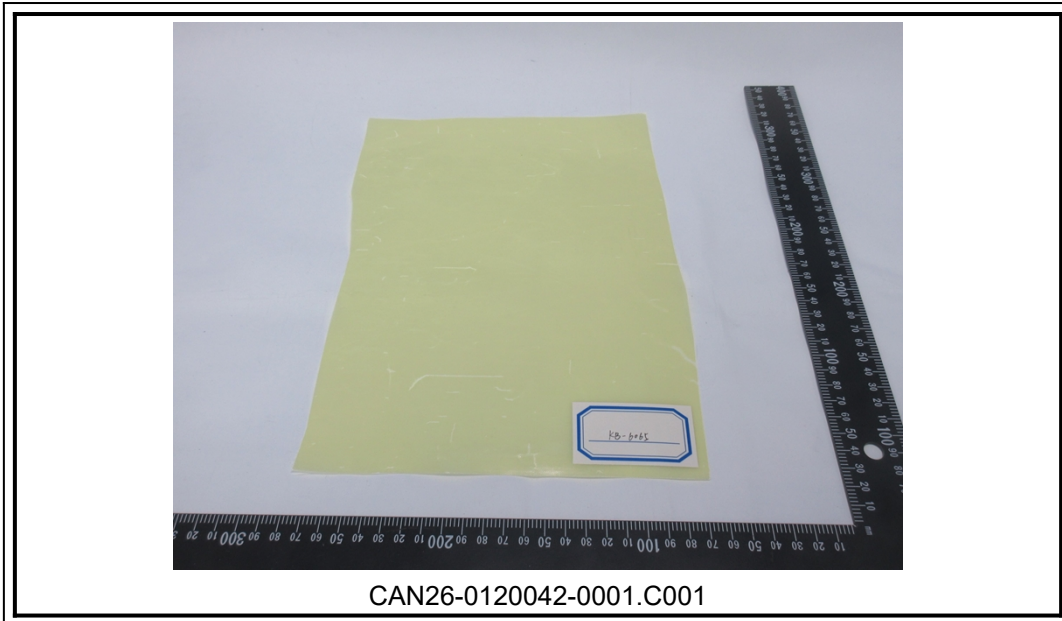
