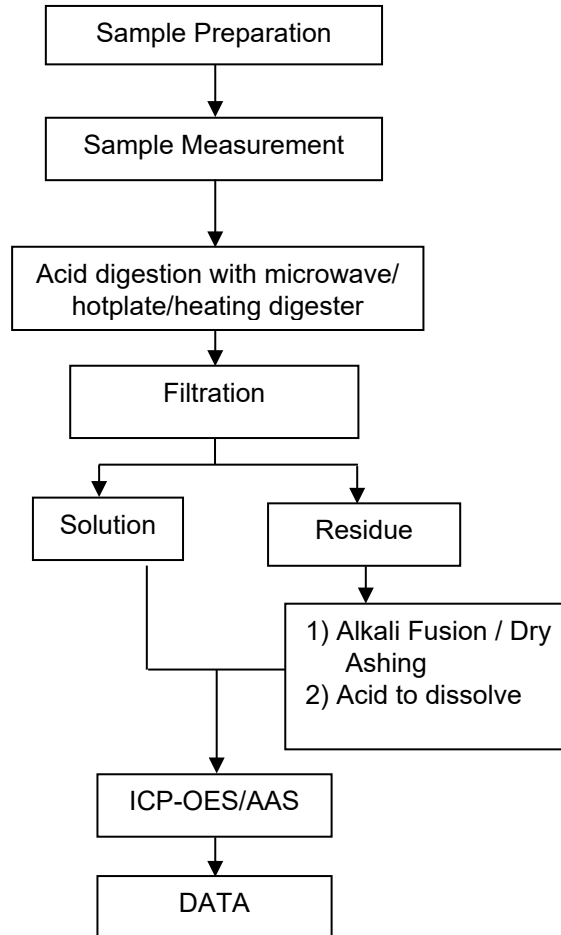

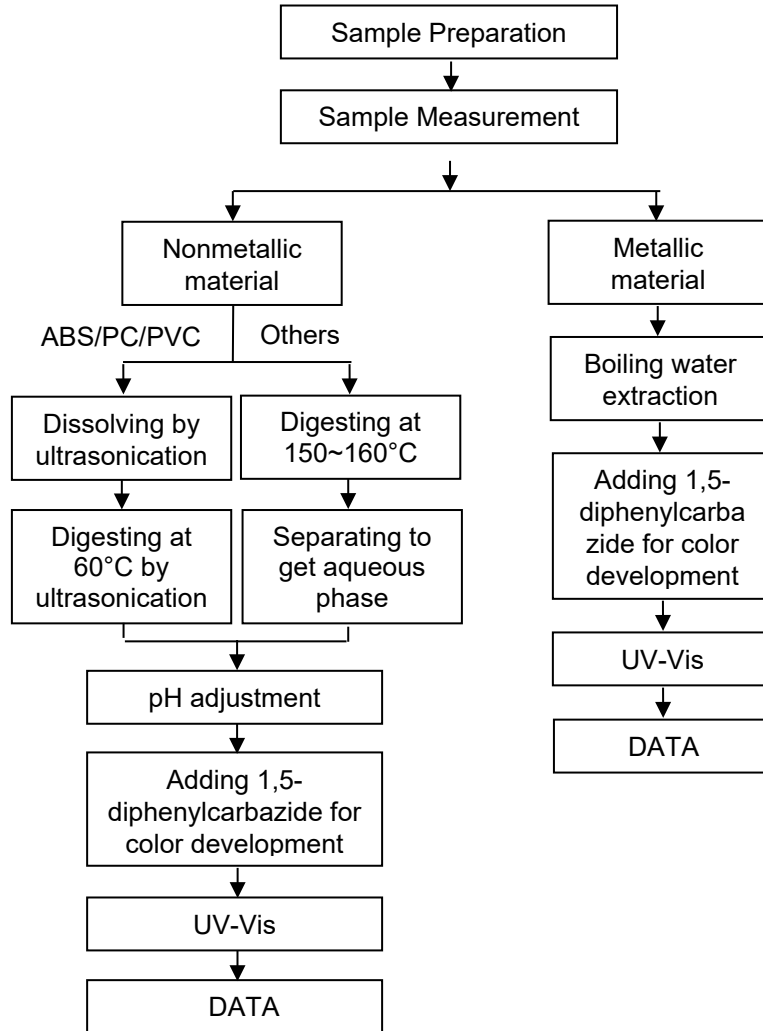

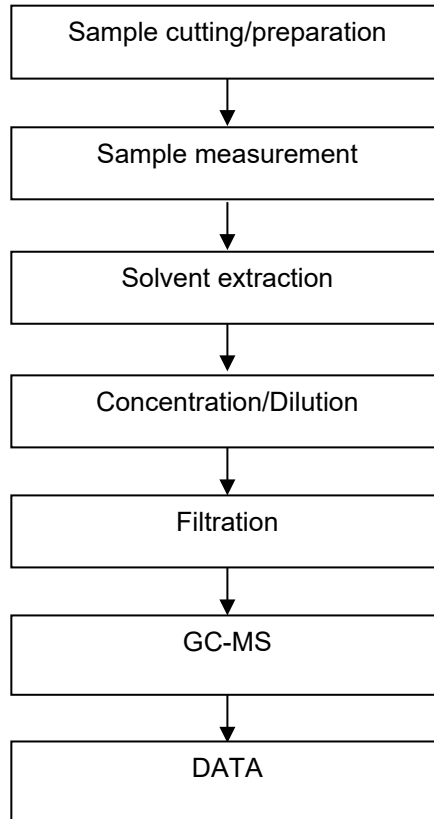


Hexavalent Chromium (Cr(VI)) Testing Flow Chart



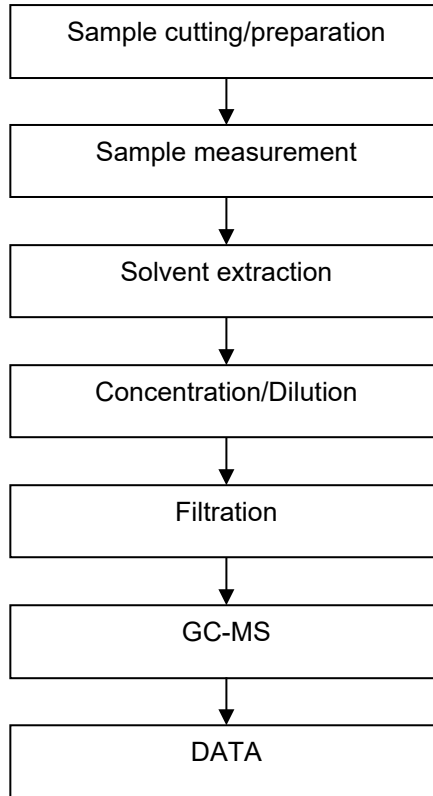

PBB(s)/PBDE(s)/Phthalates Testing Flow Chart



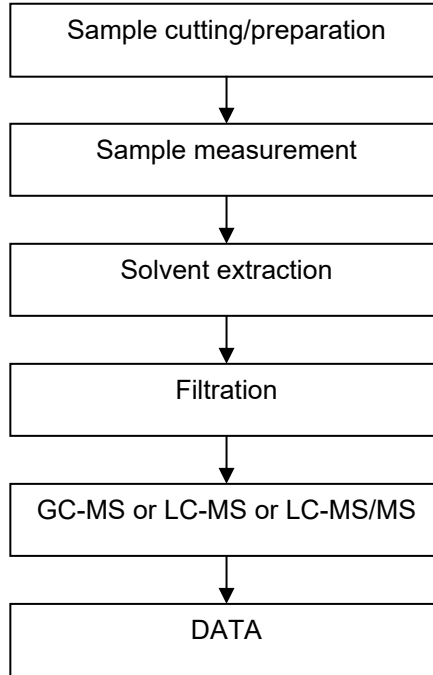

PAHs Testing Flow Chart



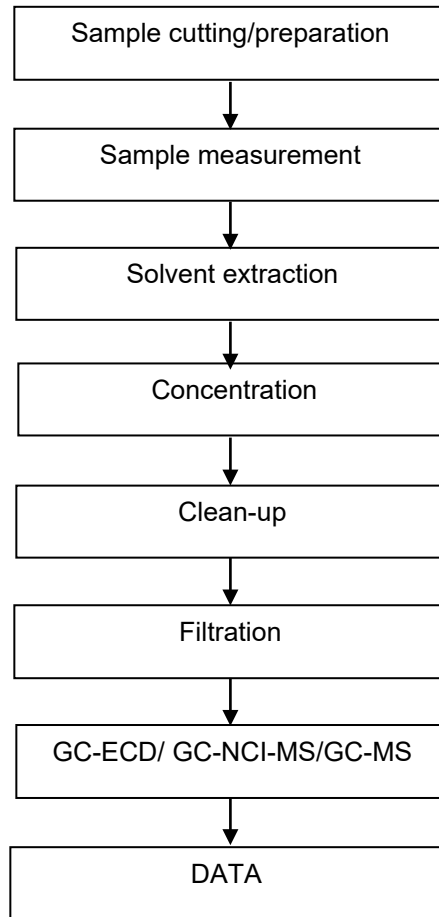

TBBP-A Testing Flow Chart

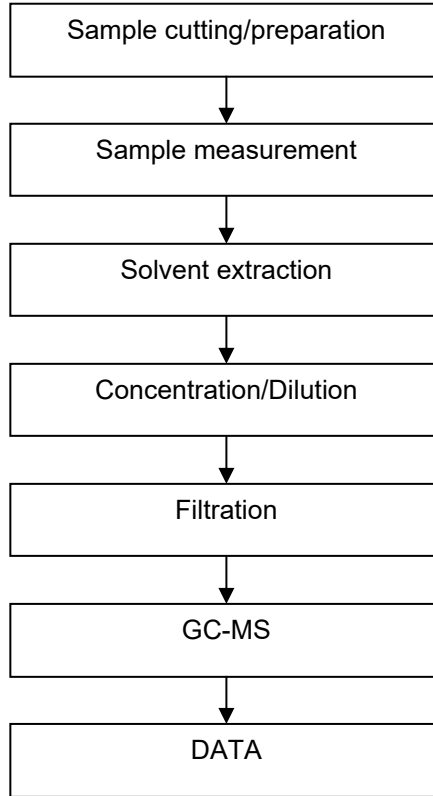

Chlorinated Paraffin Testing Flow Chart

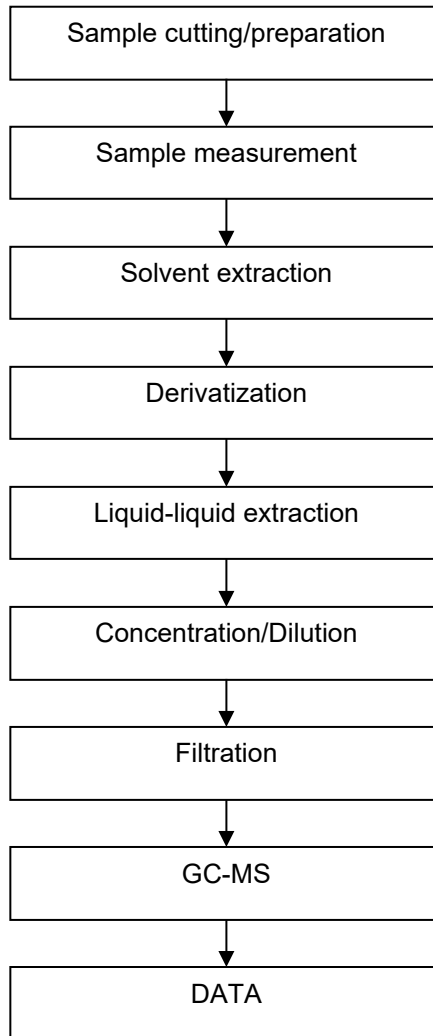


HBCDD Testing Flow Chart



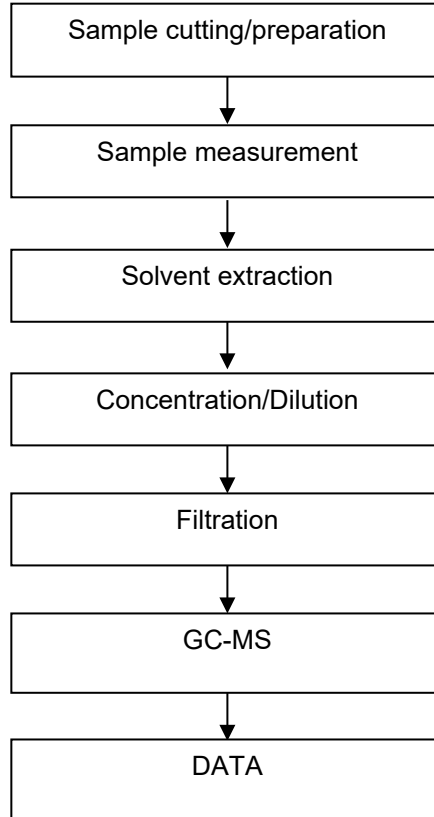

Organotin Testing Flow Chart



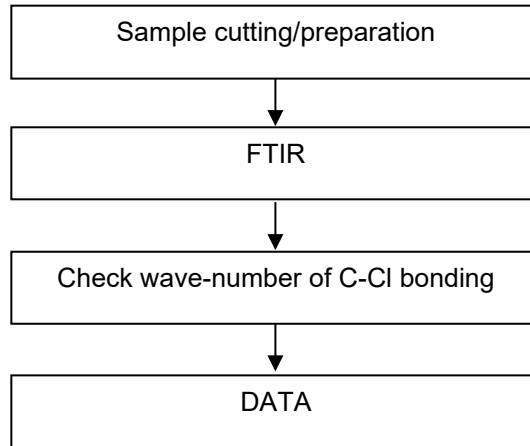

PVC Testing Flow Chart

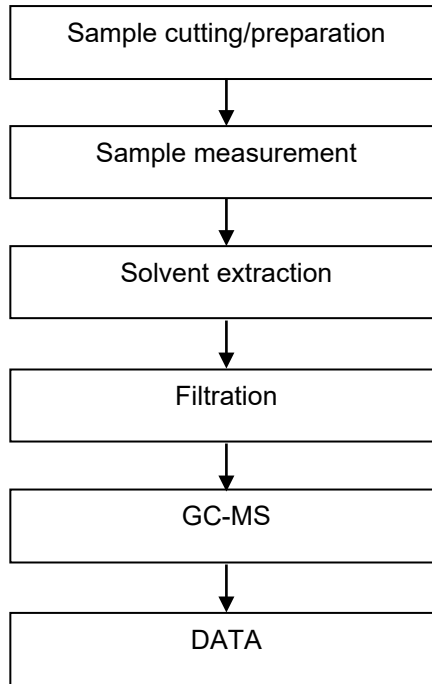

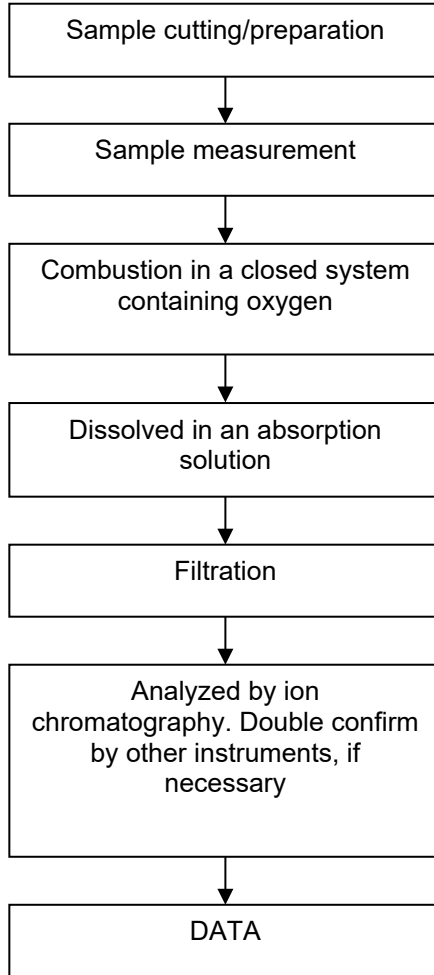

Persistent, Bioaccumulative, and Toxic (PBT) Chemicals Testing Flow Chart

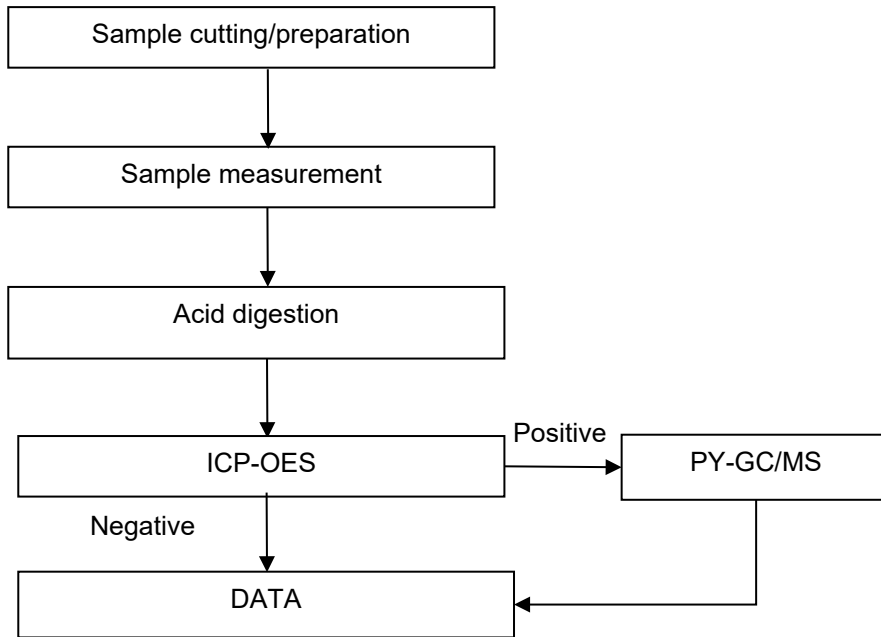


Halogen Testing Flow Chart



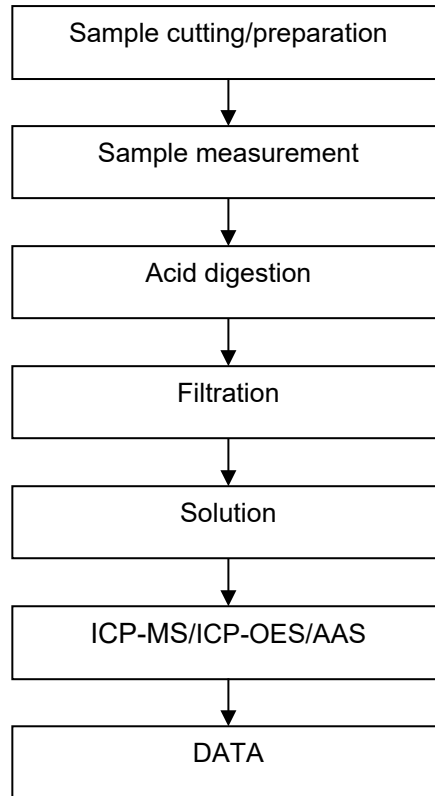

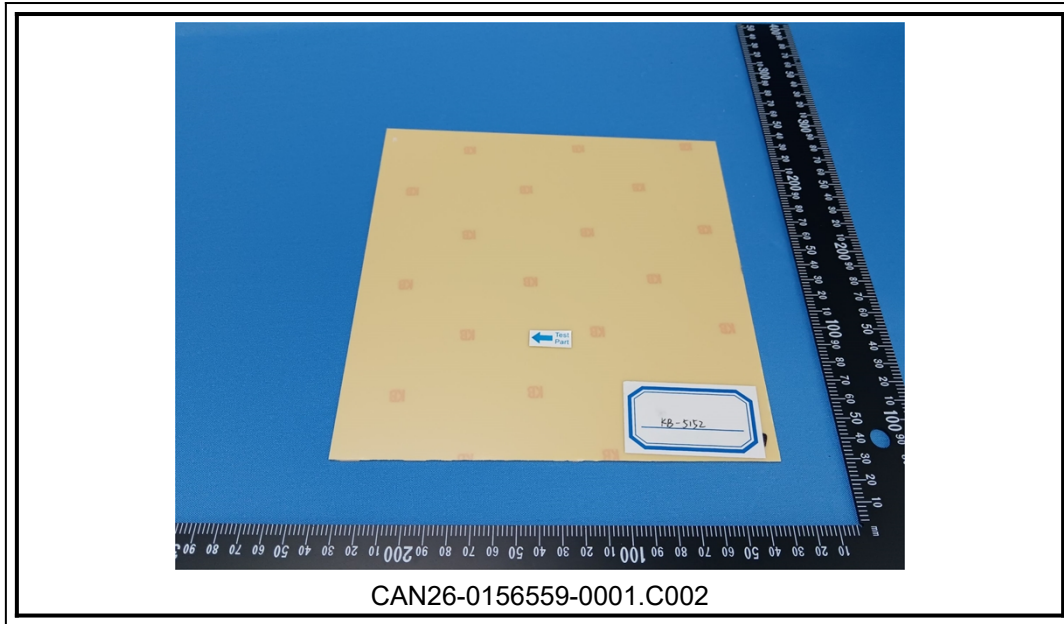
