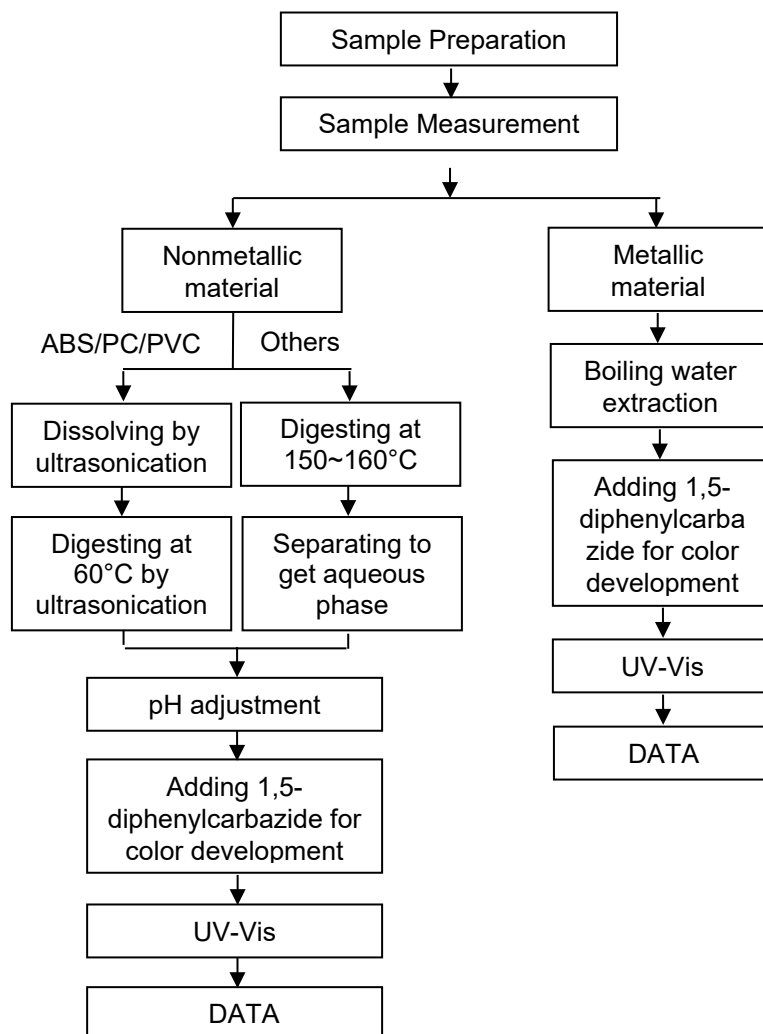

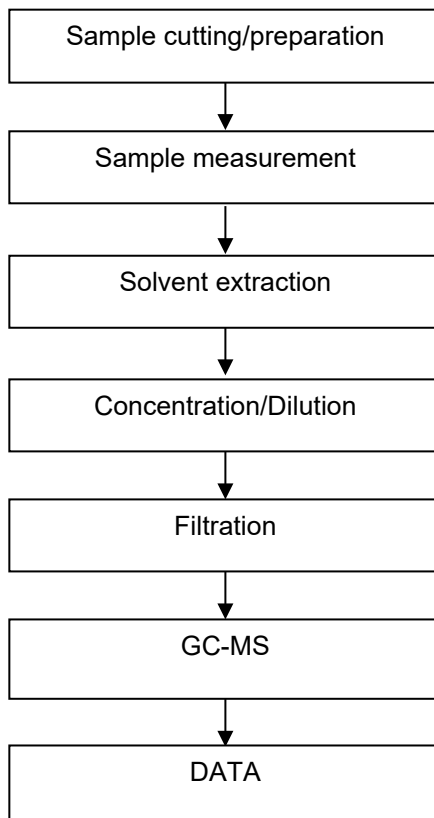

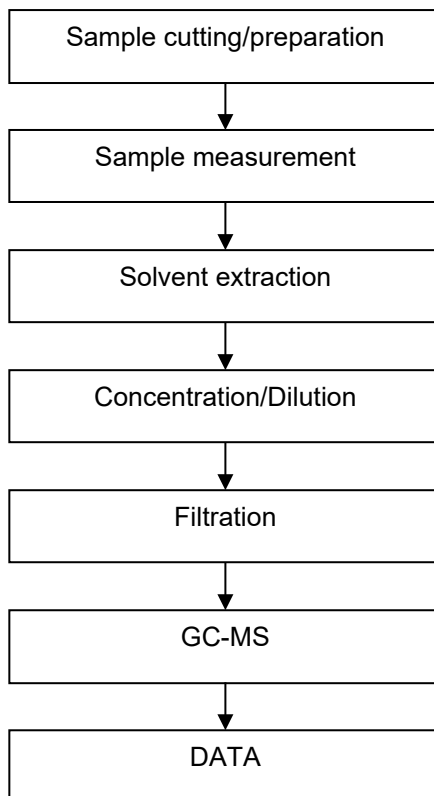

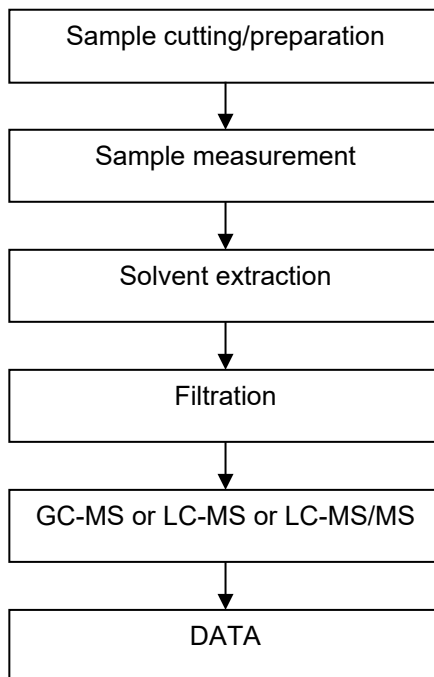

TBBP-A Testing Flow Chart



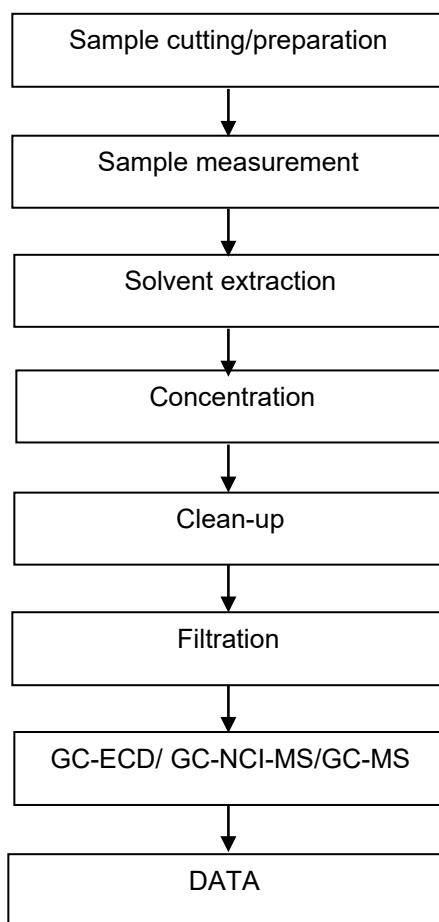

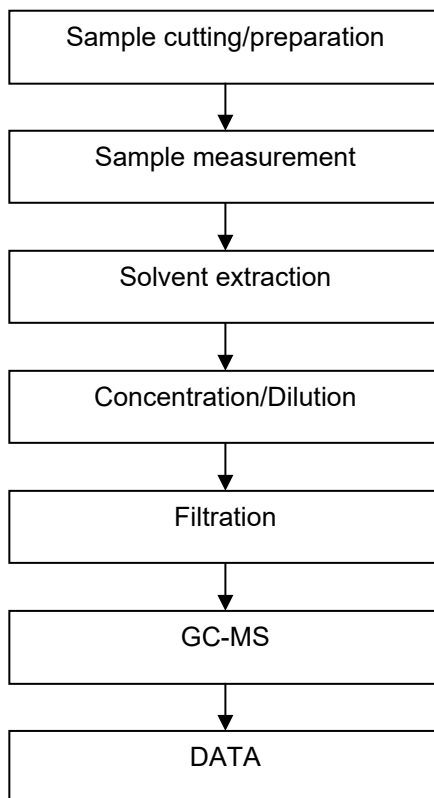

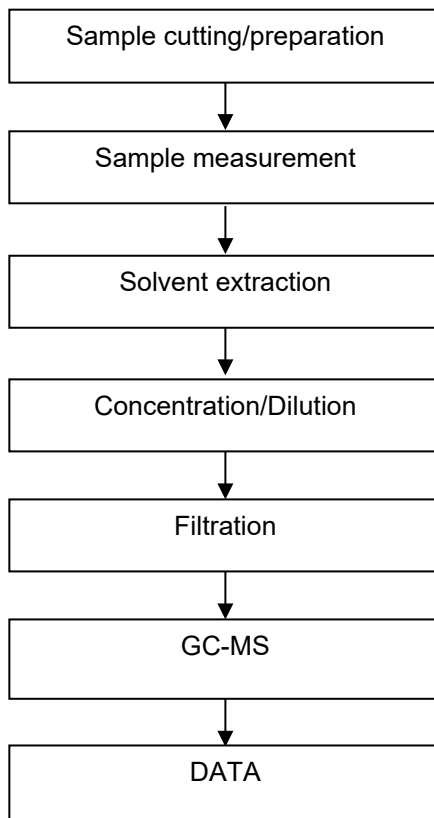

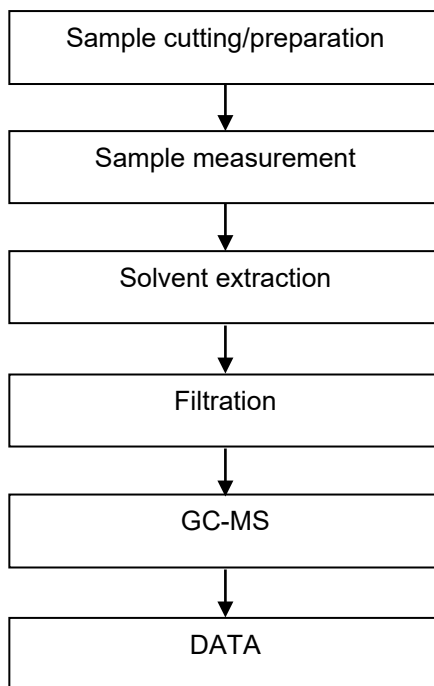

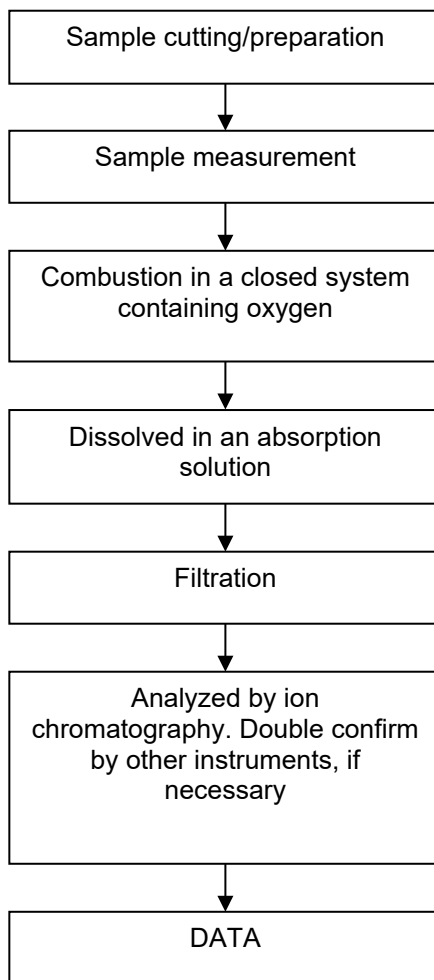

Persistent, Bioaccumulative, and Toxic (PBT) Chemicals Testing Flow Chart

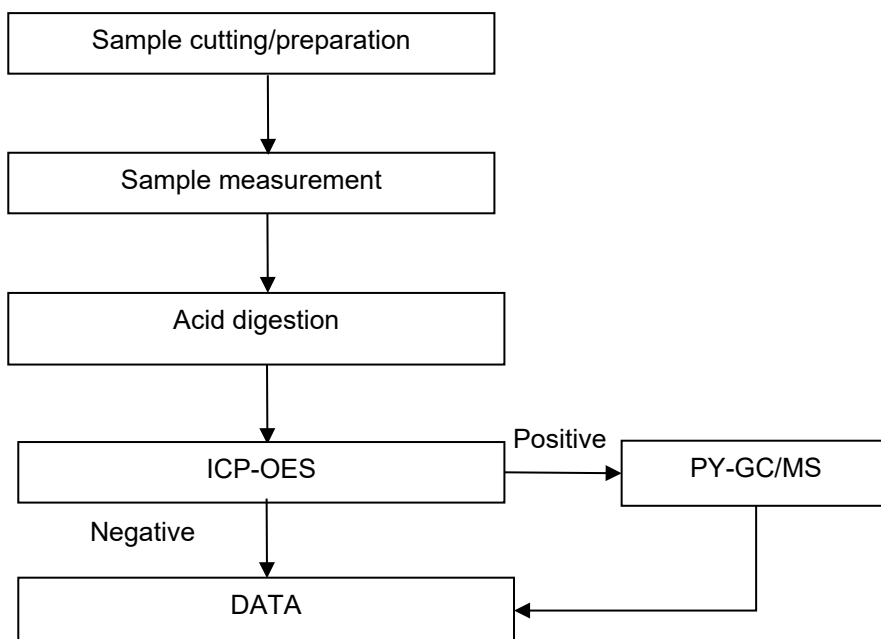


Halogen Testing Flow Chart

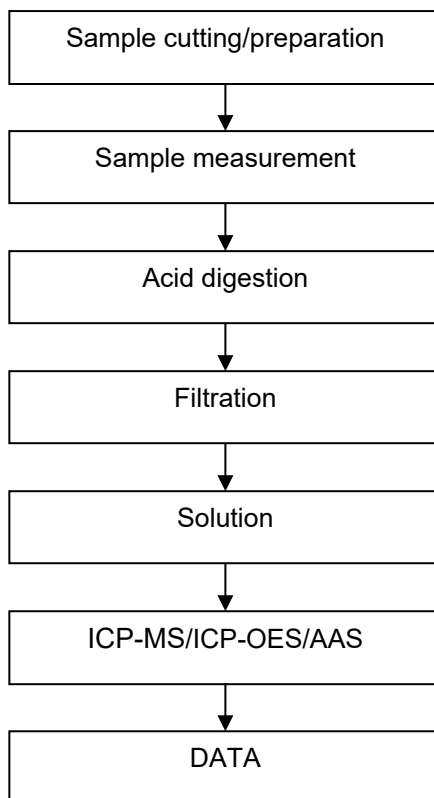

Elements Testing Flow Chart



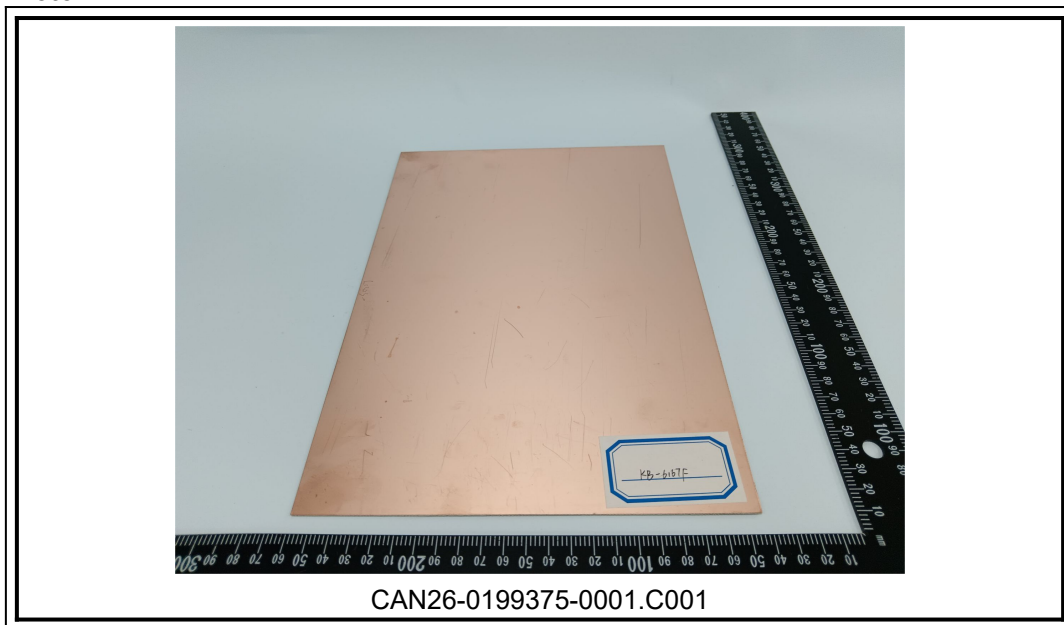
