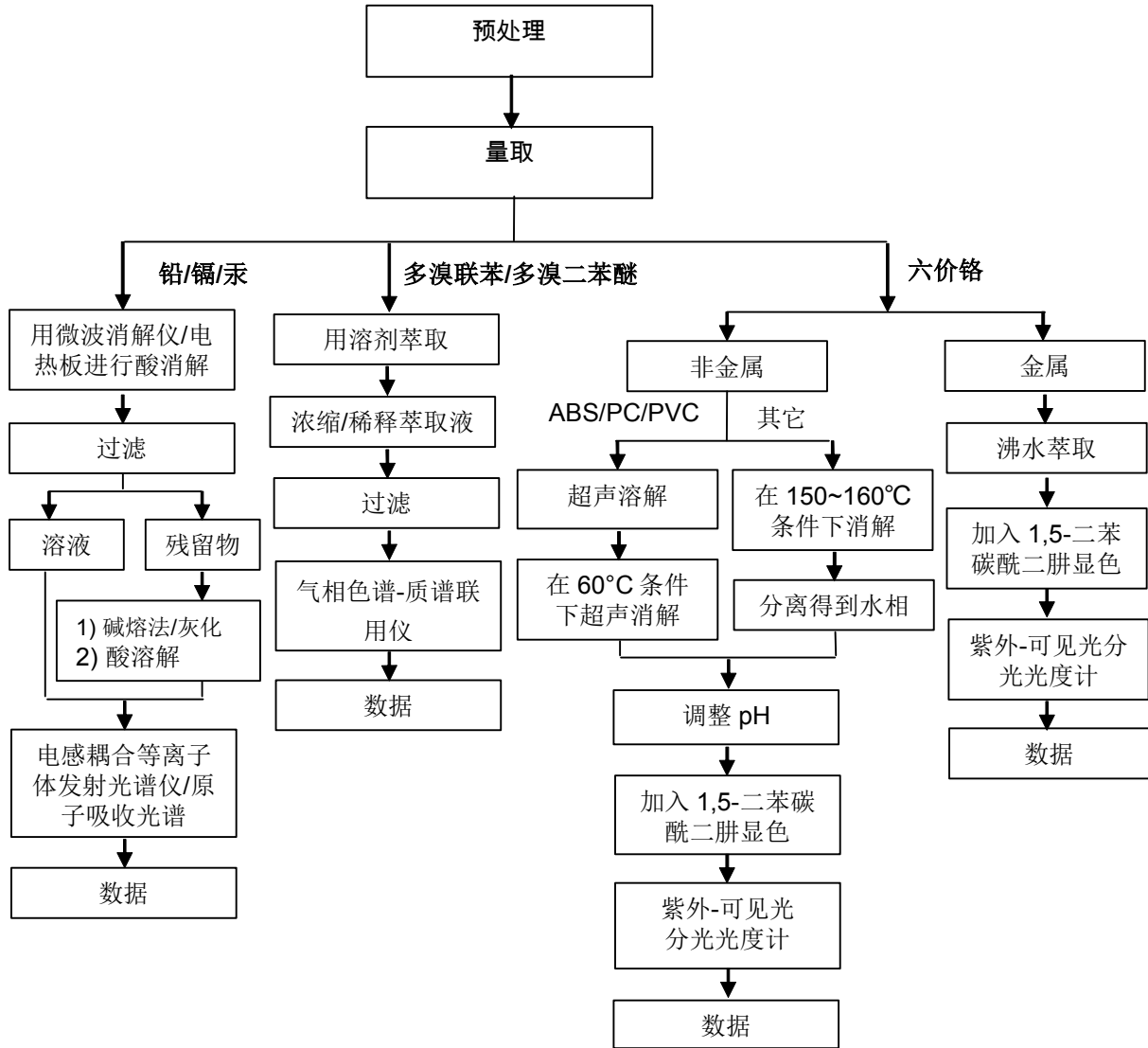

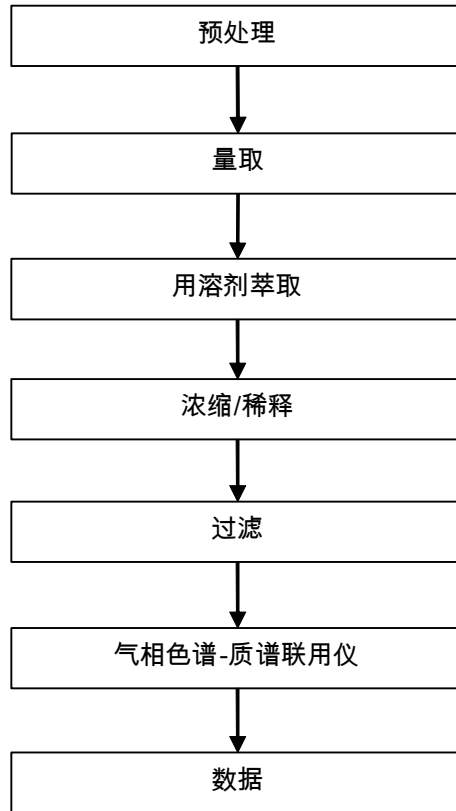

## Phthalates 测试流程图



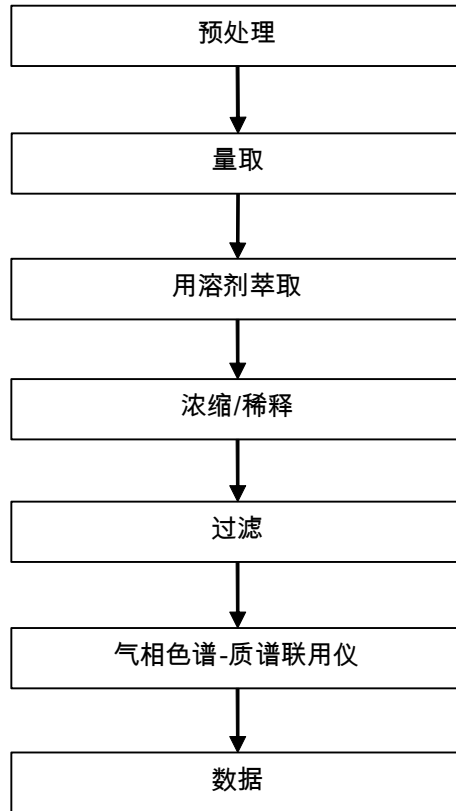

## Phthalates 测试流程图

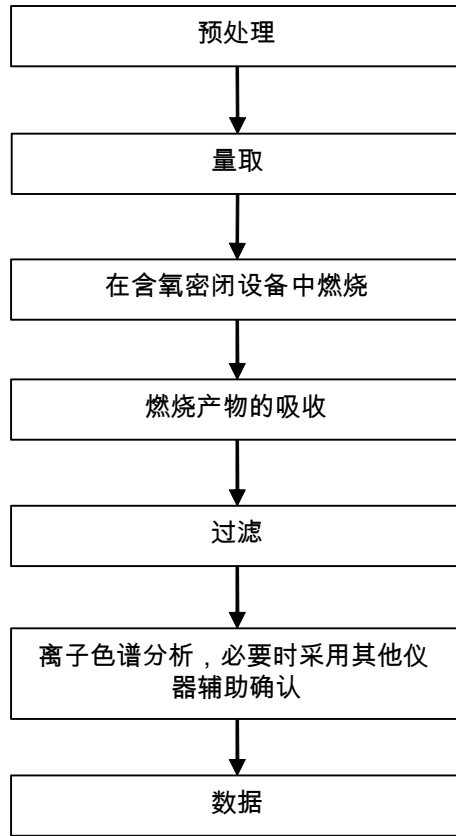

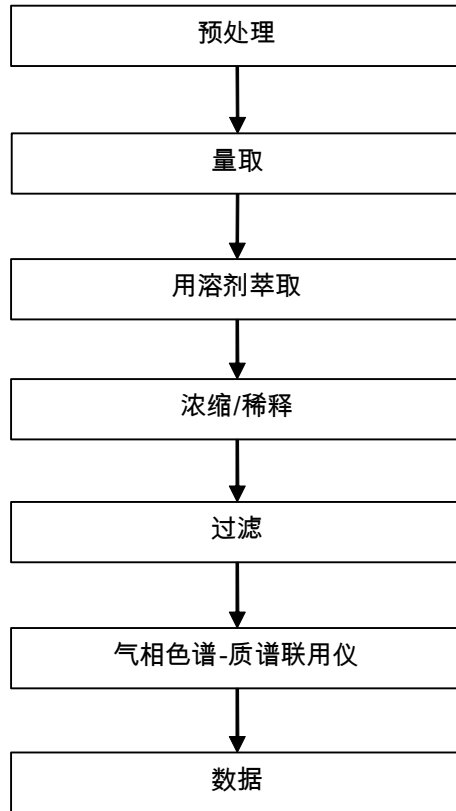

## Halogen 测试流程图



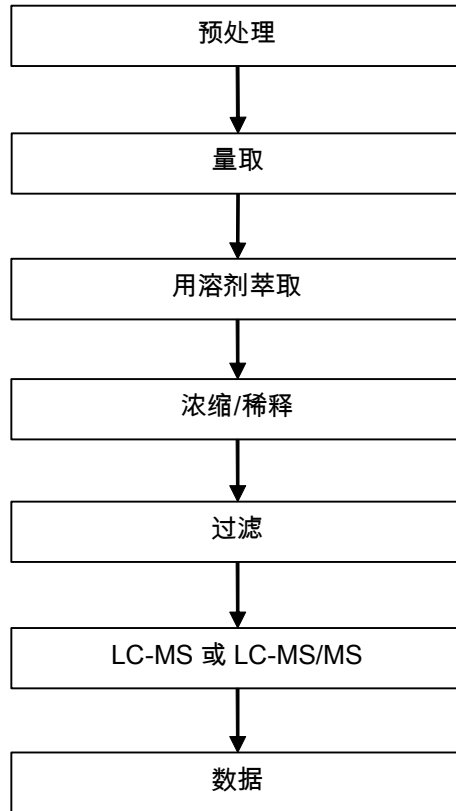

### PFOA / PFOS 测试流程图



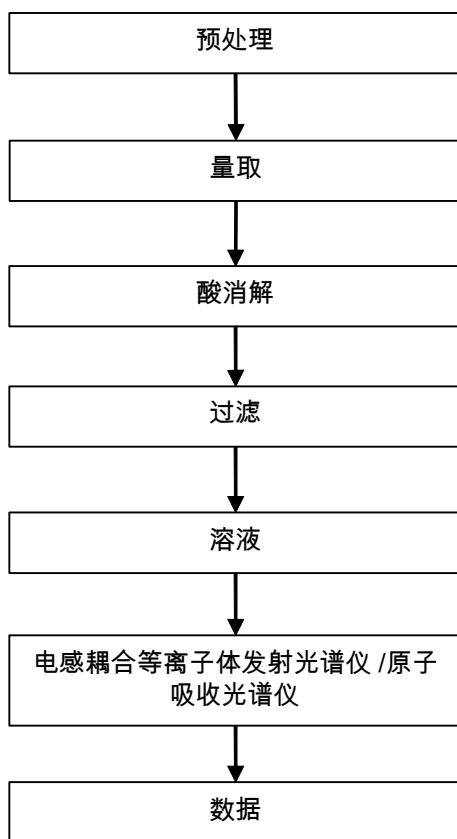

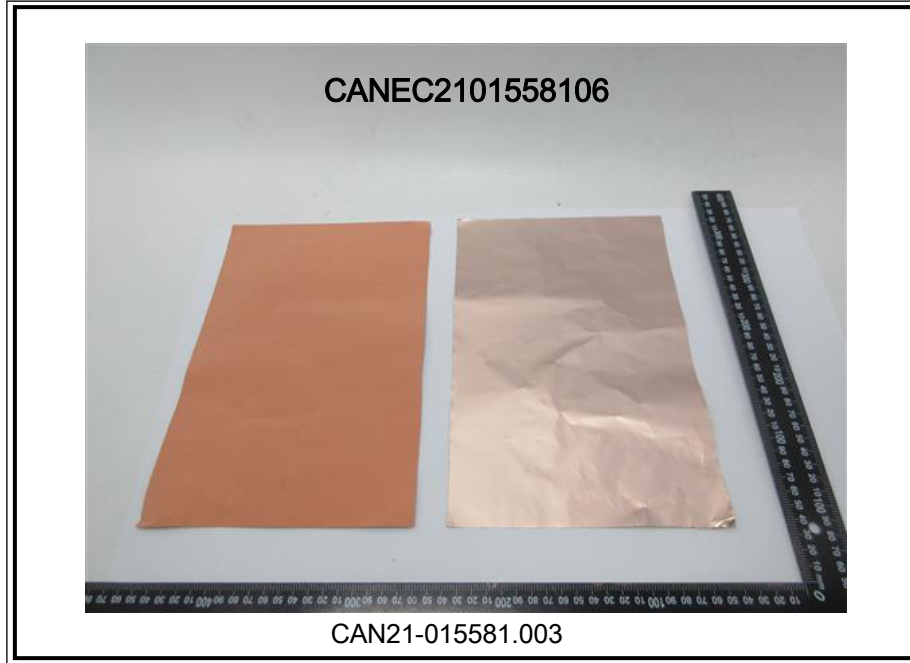
