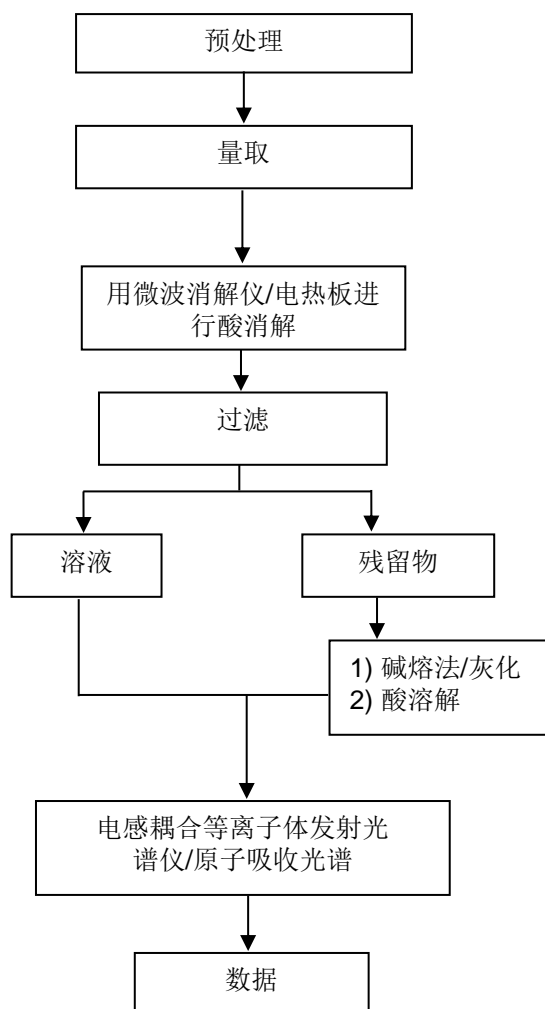

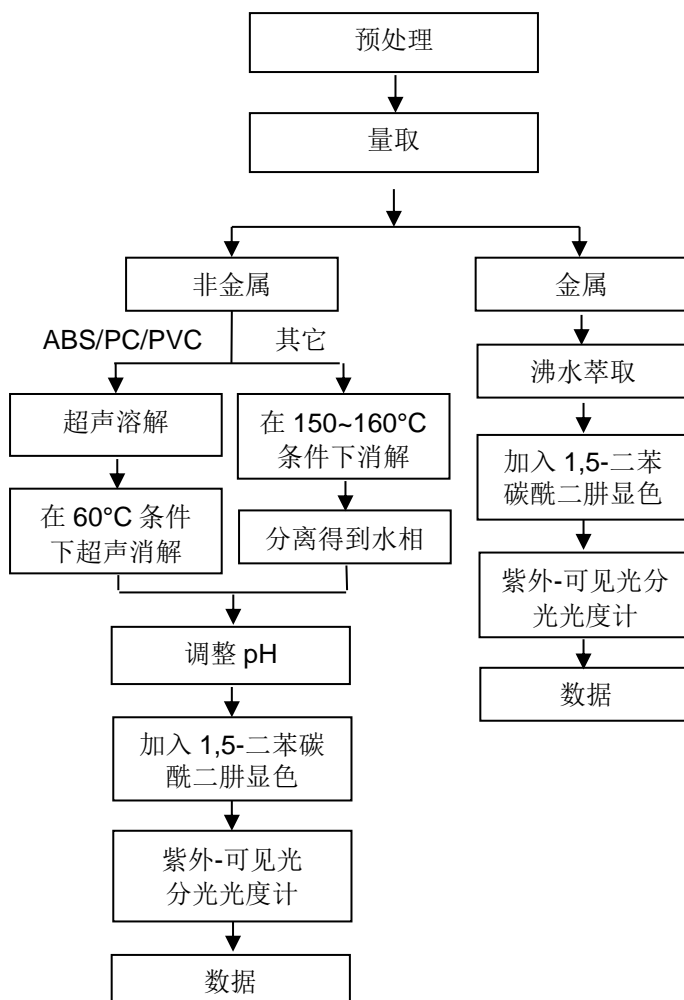

样品按照下述流程被完全消解

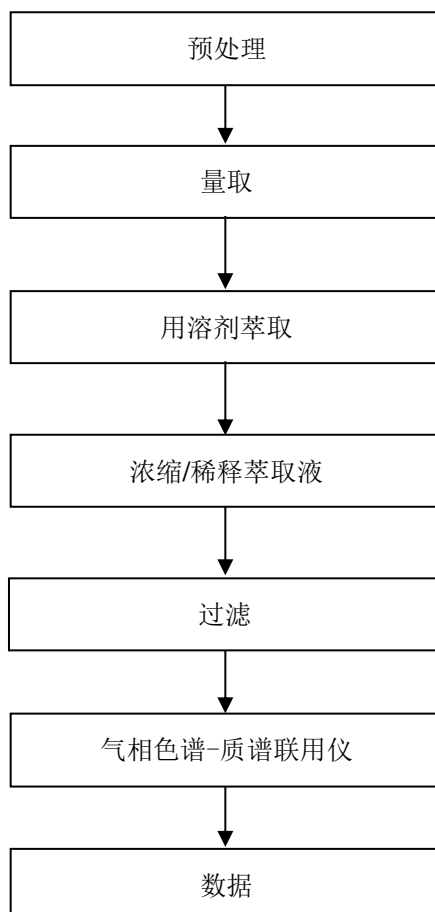


## 六价铬检测流程图

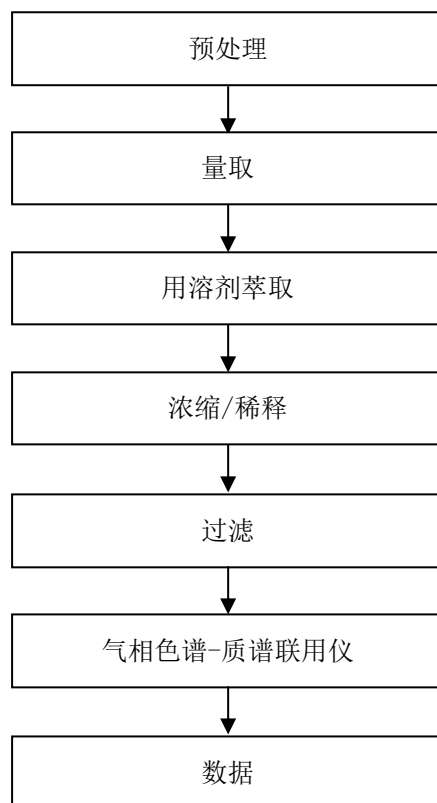




## PBBs/PBDEs 检测流程图

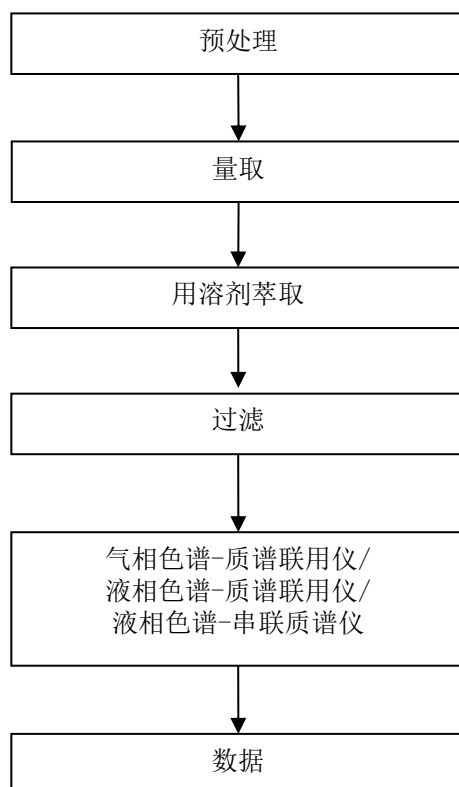


## Phthalates 检测流程图

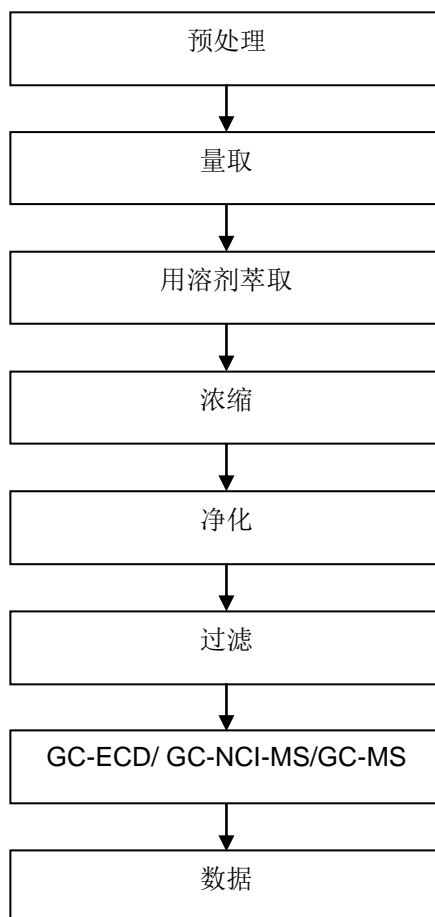

## 氯化石蜡检测流程图





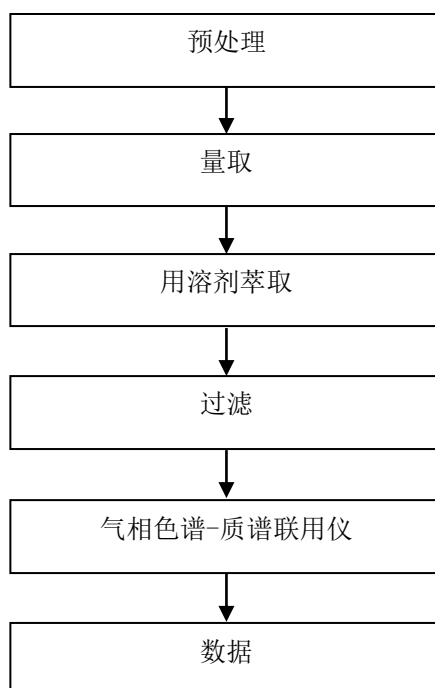

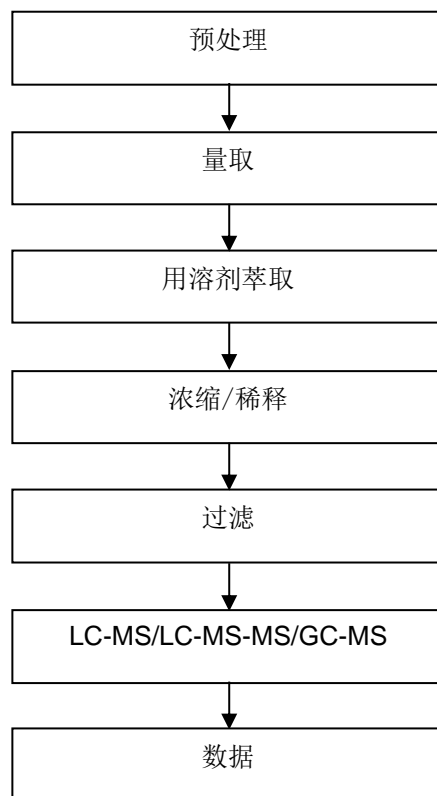

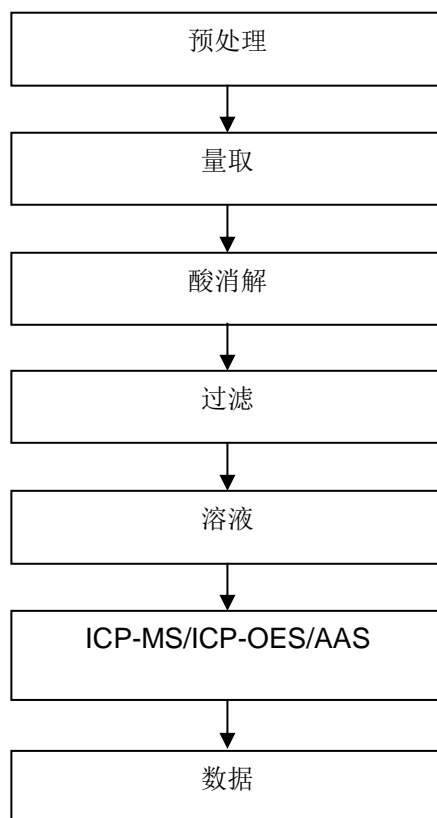
## PFASs/ PFOS/PFOA 检测流程图

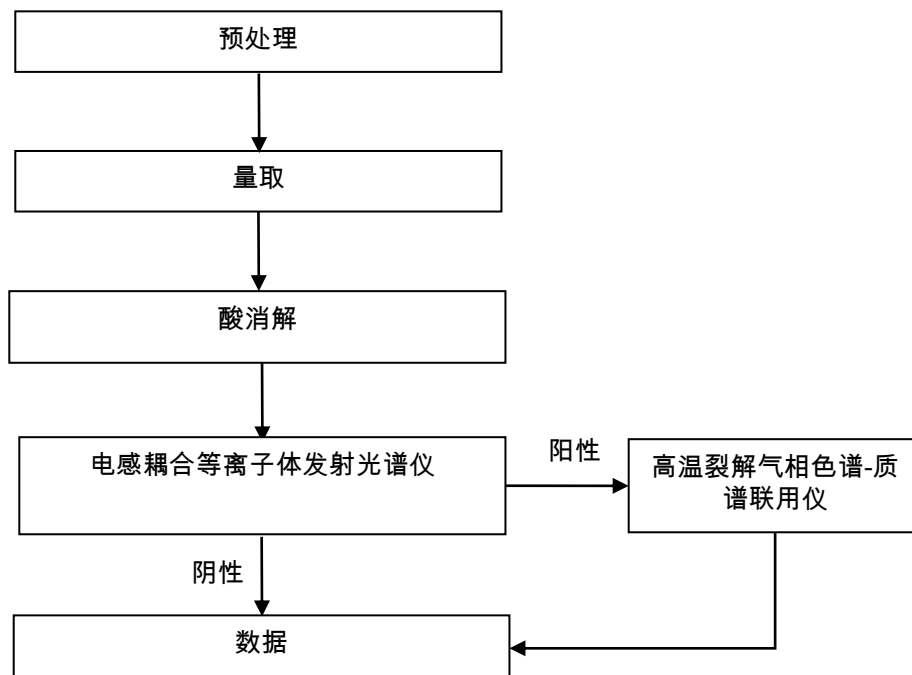

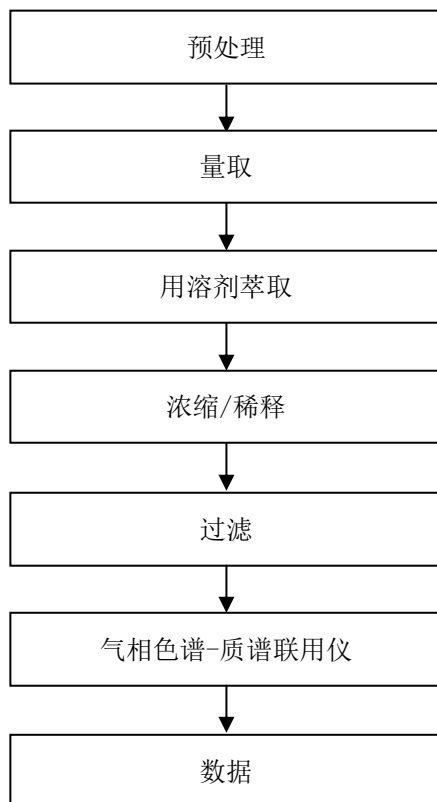
