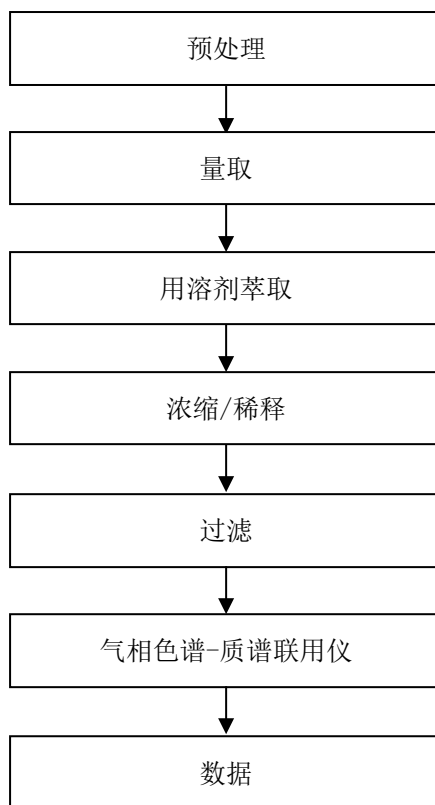

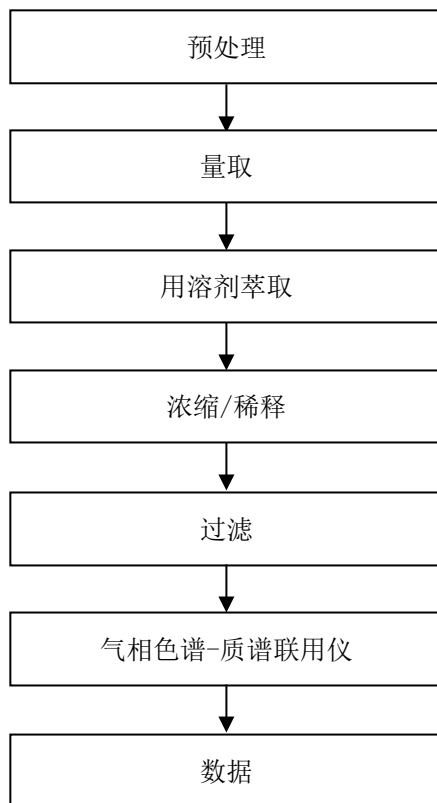
六价铬检测流程图



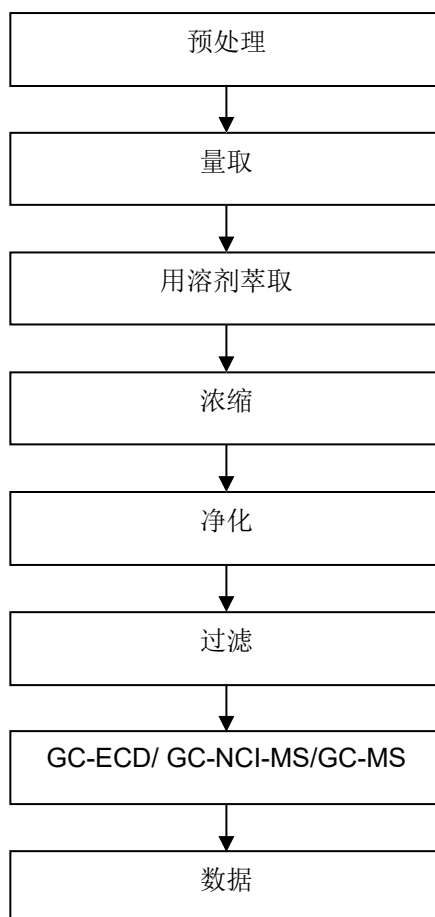
PBB/PBDE/Phthalates 检测流程图

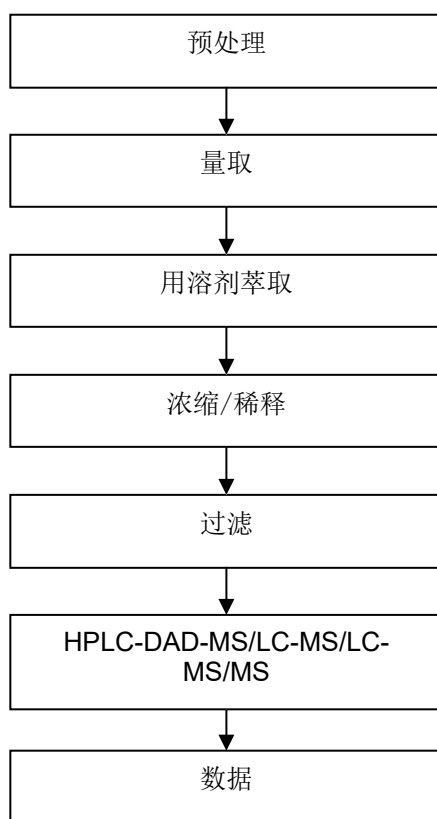

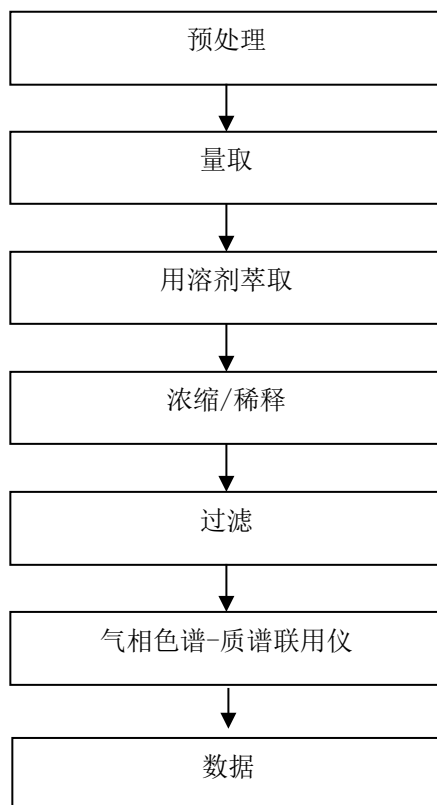

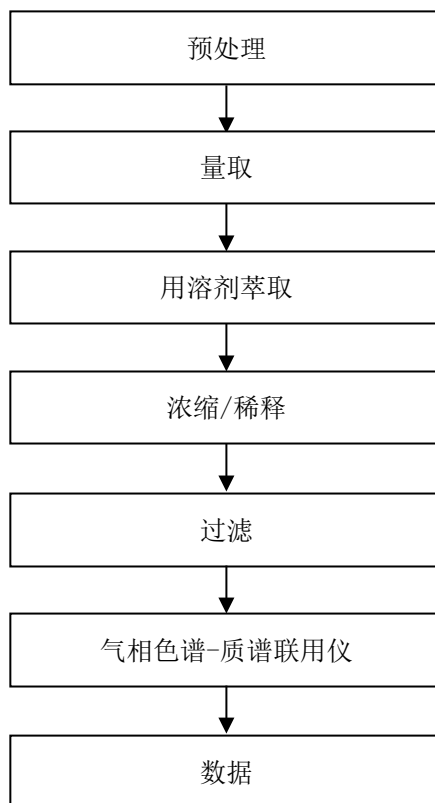
双酚类化合物检测流程图



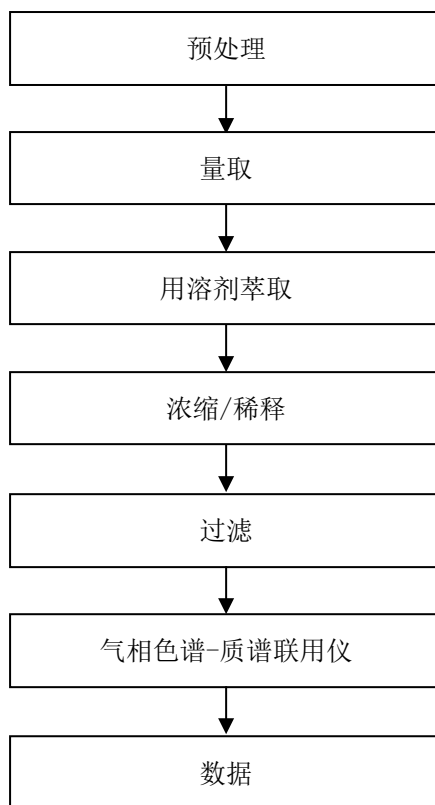
DMF(富马酸二甲酯)检测流程图



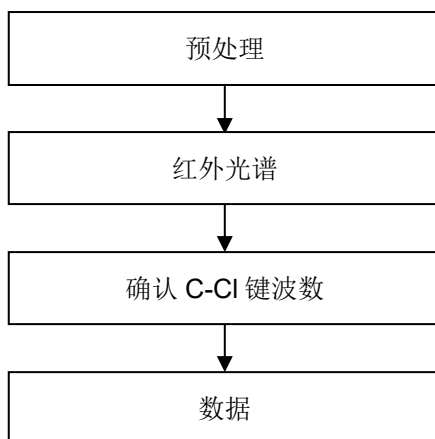
HBCDD 检测流程图



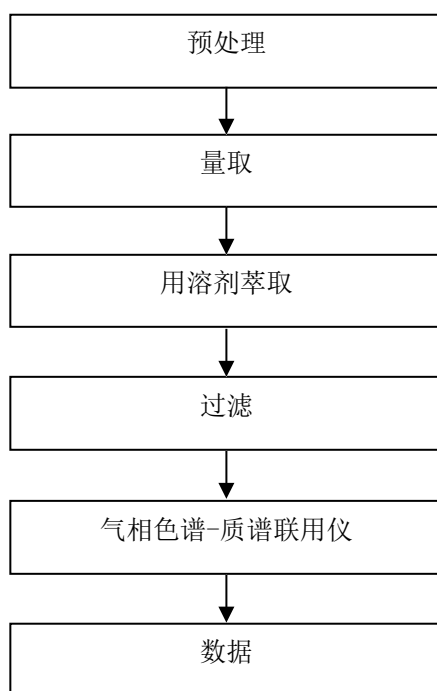
Phthalates 检测流程图



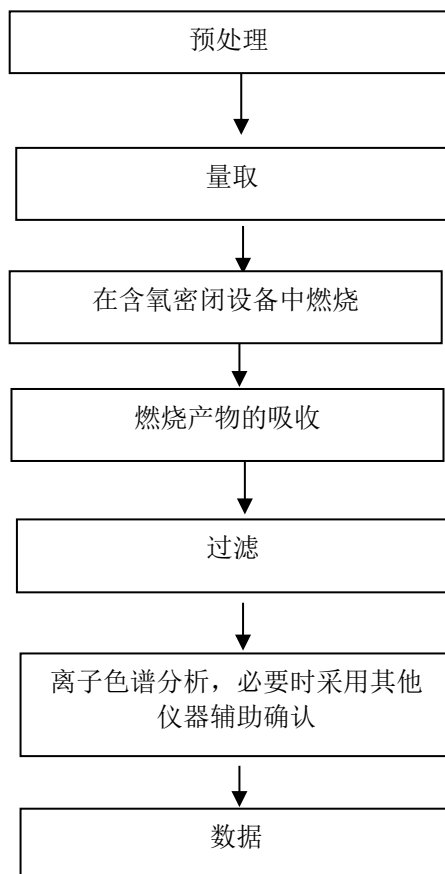
PVC 检测流程图



持久性、生物累积性和毒性 (PBT) 化学物质检测流程图

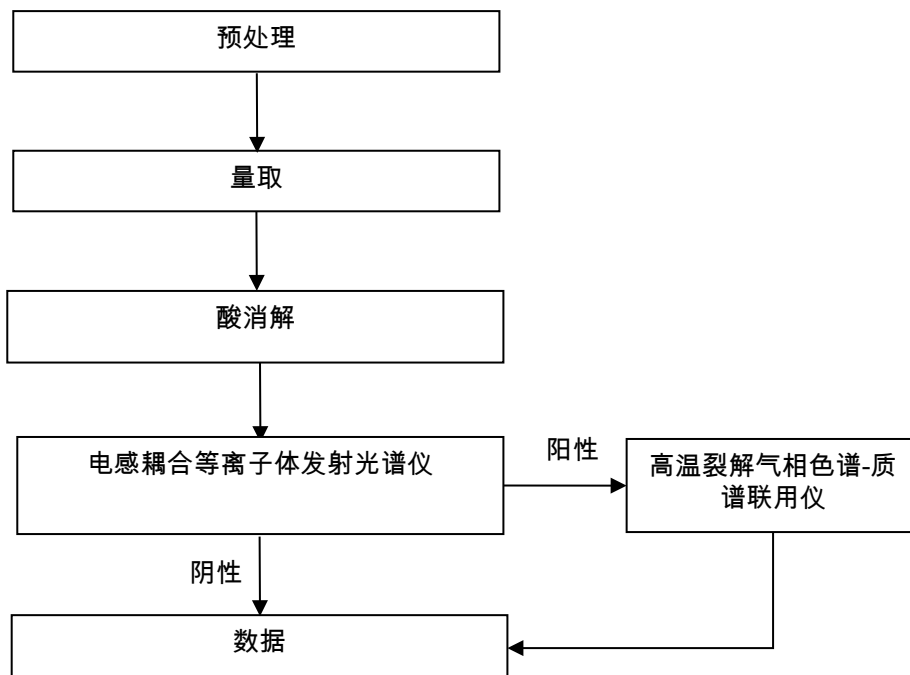

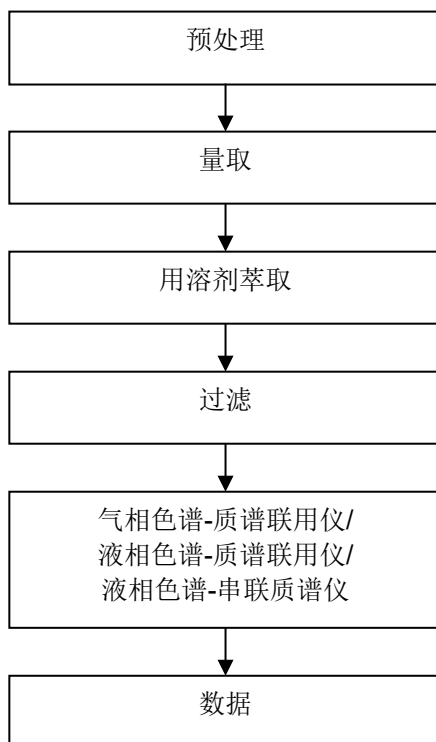
