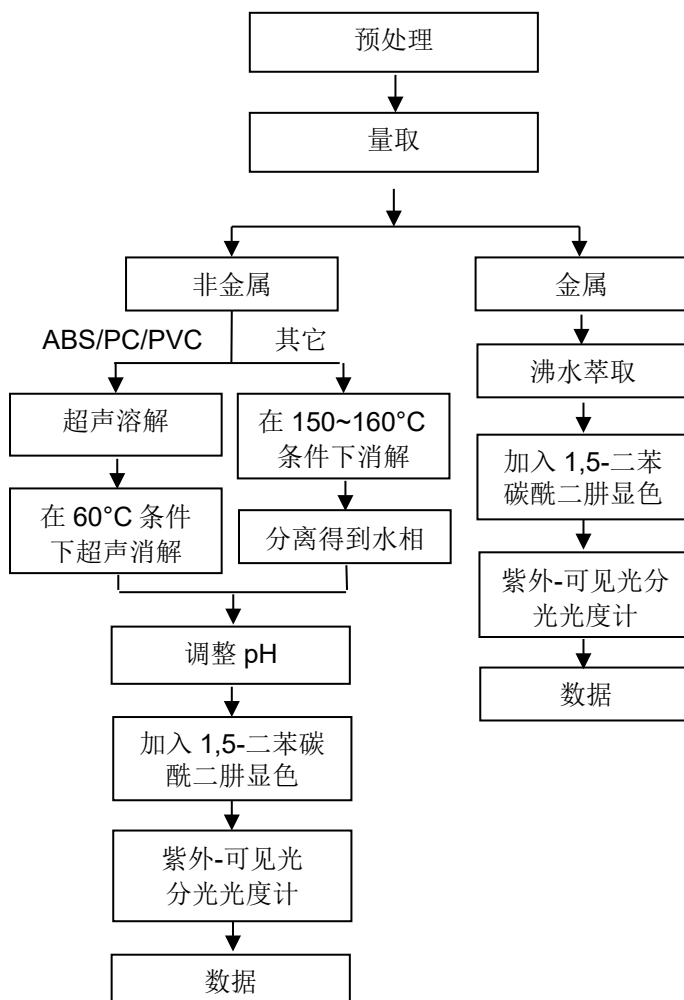

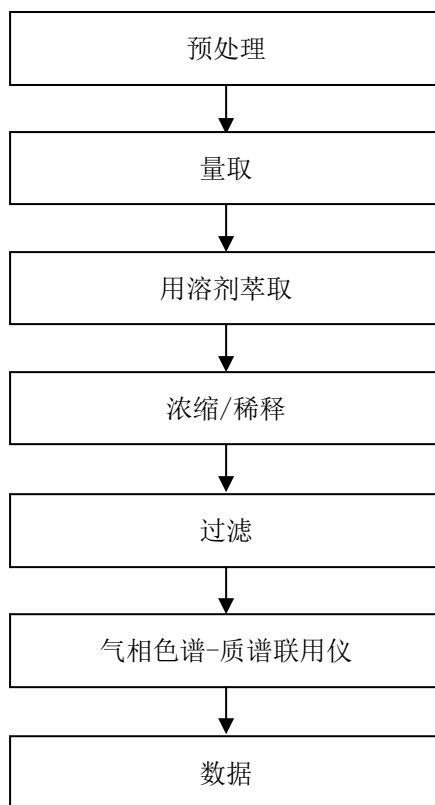

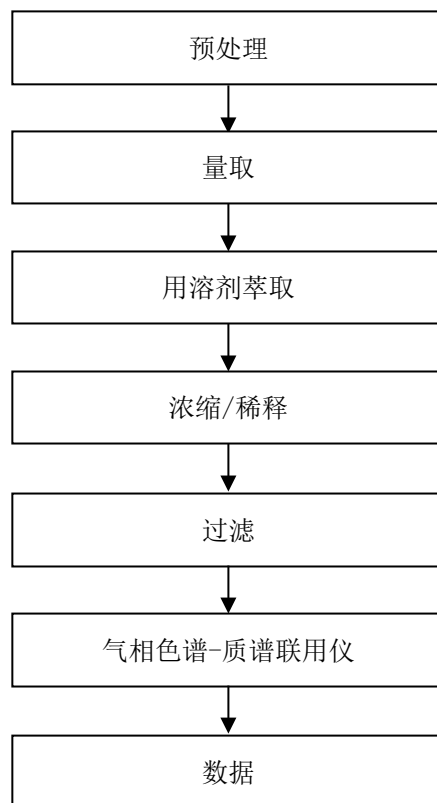
六价铬检测流程图

HBCDD 检测流程图



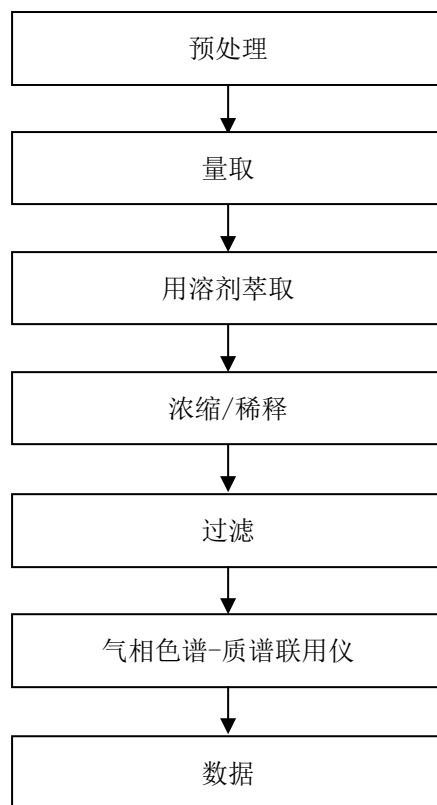
