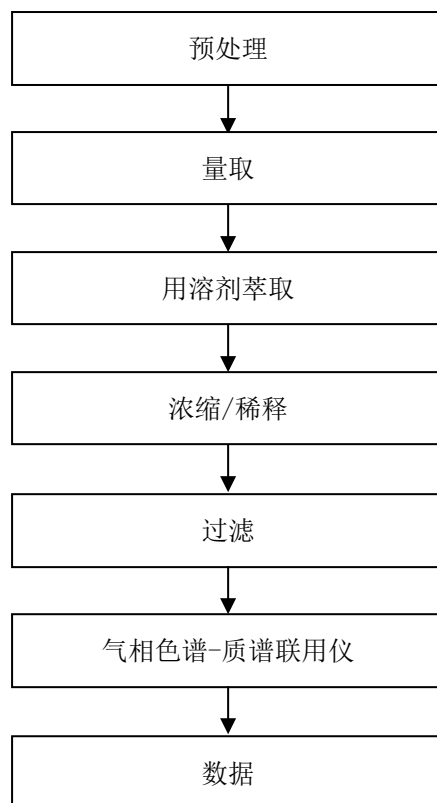

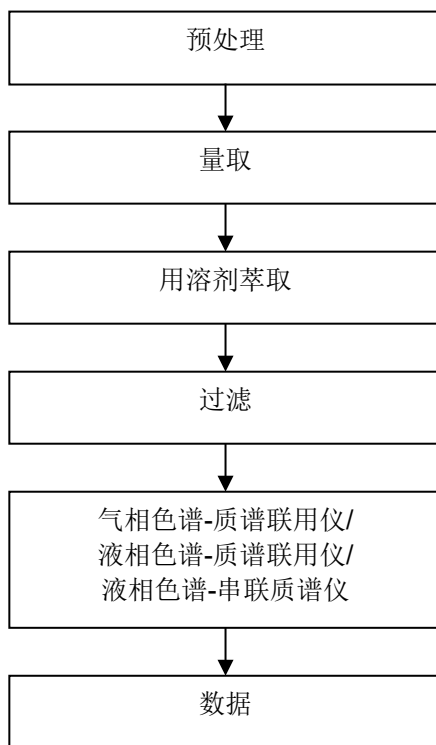

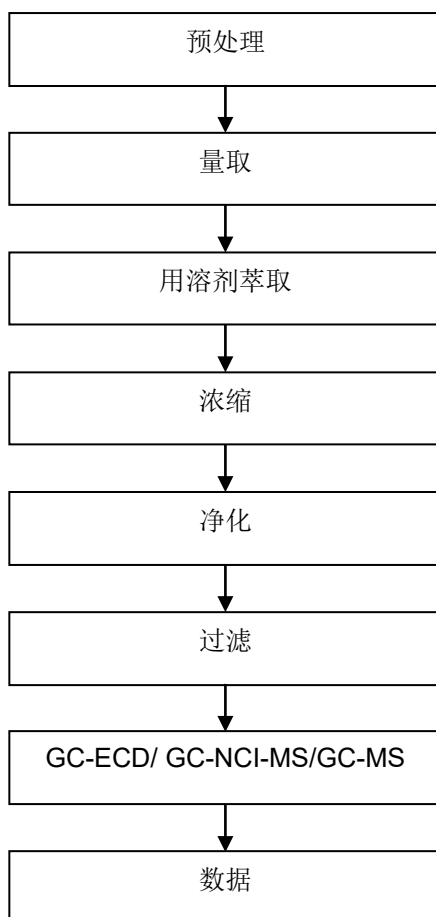
PAHs 检测流程图



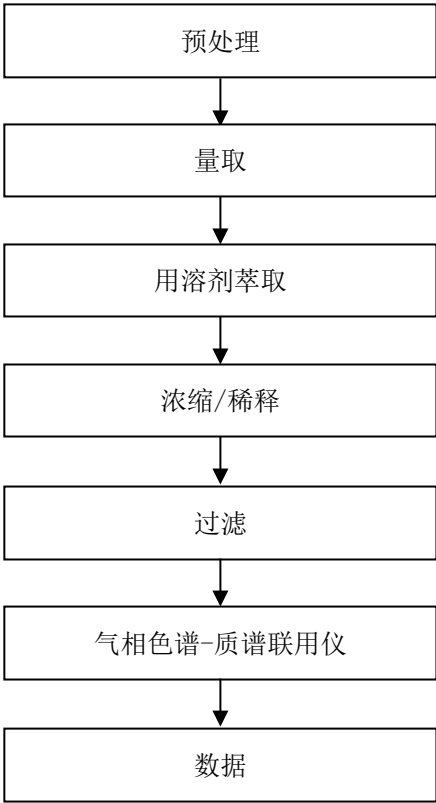
TBBP-A 检测流程图



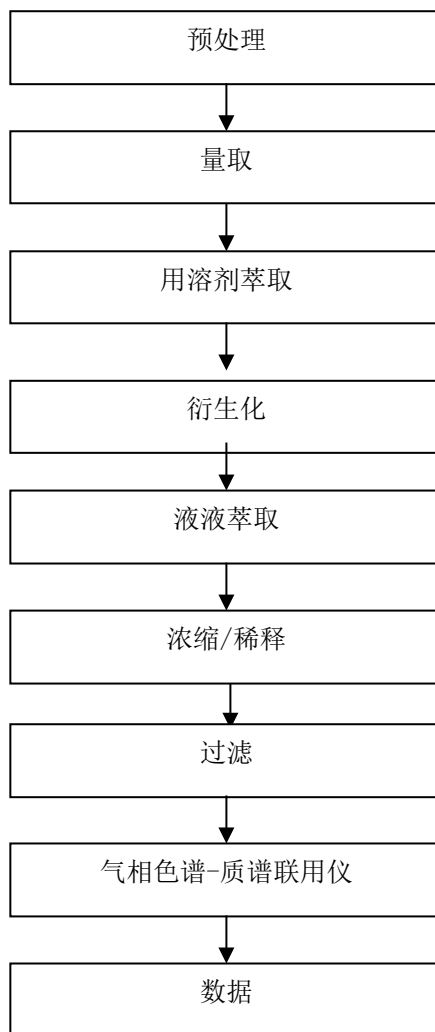

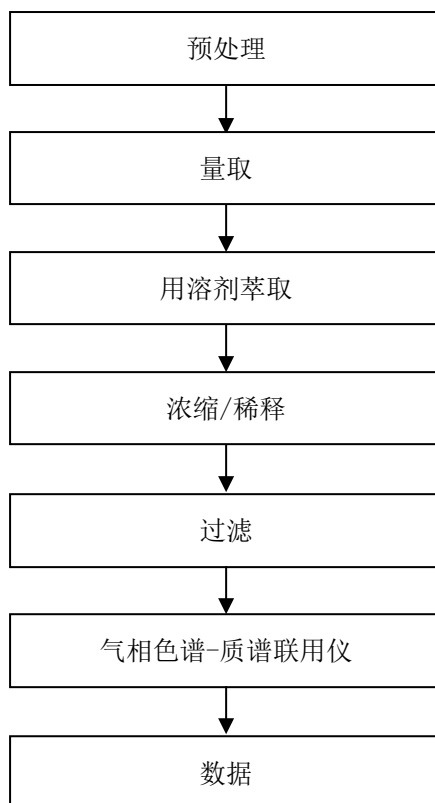
HBCDD 检测流程图



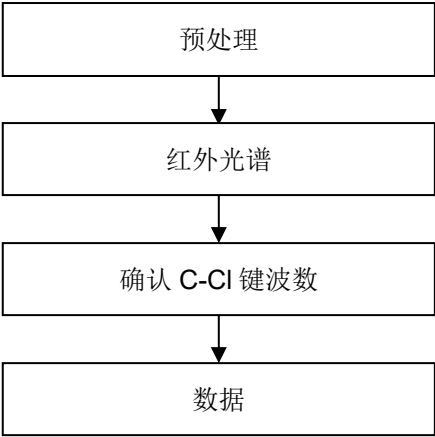

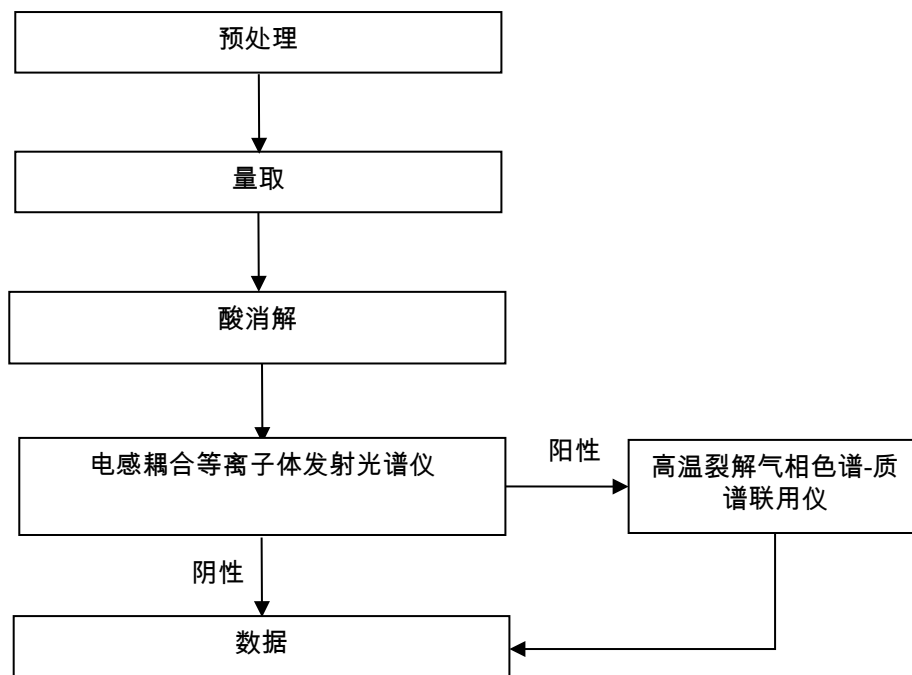
